We will always provide food, whether light bights, breakfasts, sandwiches, nibble and full main meals such as steaks etc... We need to remove the condition about alcohol only being served with table meals as due to the nature of the business and the customer it is difficult as we are licensed all day to determine exactly what would classify as a table meal and this is difficult for us to manage as well as difficult to make ur customers understand.

I must make it clear that we do NOT want to become a pub (a vertical drinking establishment), there are plenty of these around us. We would want to change nothing else just this confusing condition that is difficult for us to monitor due to varied nature of our business.


