

### Revival Conditions

#### Conditions already on the licence:

A tamper proof CCTV system shall be installed, maintained and operated at the premises in liaison with and to the satisfaction of Lancashire Constabulary and shall be used to record during all hours that the premises are open to the public. (This will be replaced with the agreed conditions).

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

From 2300 hours to closing time, there shall be provided at the premises a minimum of three door supervisors who are registered with the Security Industry Authority.

Children under the age of 16 years shall only be permitted on the premises if they are accompanied by a person aged 18 years or over and must leave the premises by no later than 2000 hours on any day.

Children aged 16 to 17 years shall be permitted on the premises either accompanied or unaccompanied but must leave the premises by no later than 2200 on any day, with the exception of staff employed at the premises.

The level of noise emitted from the premises should not be more than 5dB above background noise at any time as measured from the boundary of the premises.

There shall be no admission after 0400 hours on Thursday, Friday, Saturday, Christmas Eve, Boxing Day, New Year's Eve, New Year's Day and every Sunday before an official English Bank Holiday Monday.

There shall be no admission after 0130 hours on Sunday to Wednesday.

The mandatory age verification policy shall specify an age of 25 years.

#### Conditions from the variation application:

Customer access to the premises shall not be other than by the door indicated on the attached plan referenced as "Entrance Plan – LIC/01".

Customer re-entry to the premises will be permitted from the rear entrance.

#### Conditions agreed with the Chief Officer of Police:

A tamper proof system shall be installed, maintained and operated at the premises in liaison with and to the satisfaction of Lancashire Constabulary and shall be used to record during all hours that the premises are open to the public.

All public areas of the licensed premises, including all public entry and exit points, and the street environment will be covered by CCTV and must enable facial identification of every person entering in any light condition.

The images recorded by the CCTV system shall be retained in unedited form for a period of not less than 31 days.

If the CCTV hard drive is removed for replacement, maintenance, or any other reason, the hard drive and images recorded shall be made available to any Police Officer or authorised officer of Rossendale Borough Council for a period of 31 days.

A member of staff who is trained in the use of the CCTV system must be available at all times that the premises are open.

CCTV footage must be made available to Lancashire Constabulary or Authorised Officer of Rossendale Borough Council and must be provided within 72hours of a request being made.

In addition to the above condition, there must also be a sufficient number of SIA registered door staff during any boxing or wrestling event taking place at the premises. The number of door staff required must be determined by a written risk assessment which must be made available to a Police Constable or Authorised Officer upon request.  
**(If granted, this condition will be moved closer to other relevant conditions on the licence.)**

The premises licence holder will be responsible for the creation of the above risk assessment.
