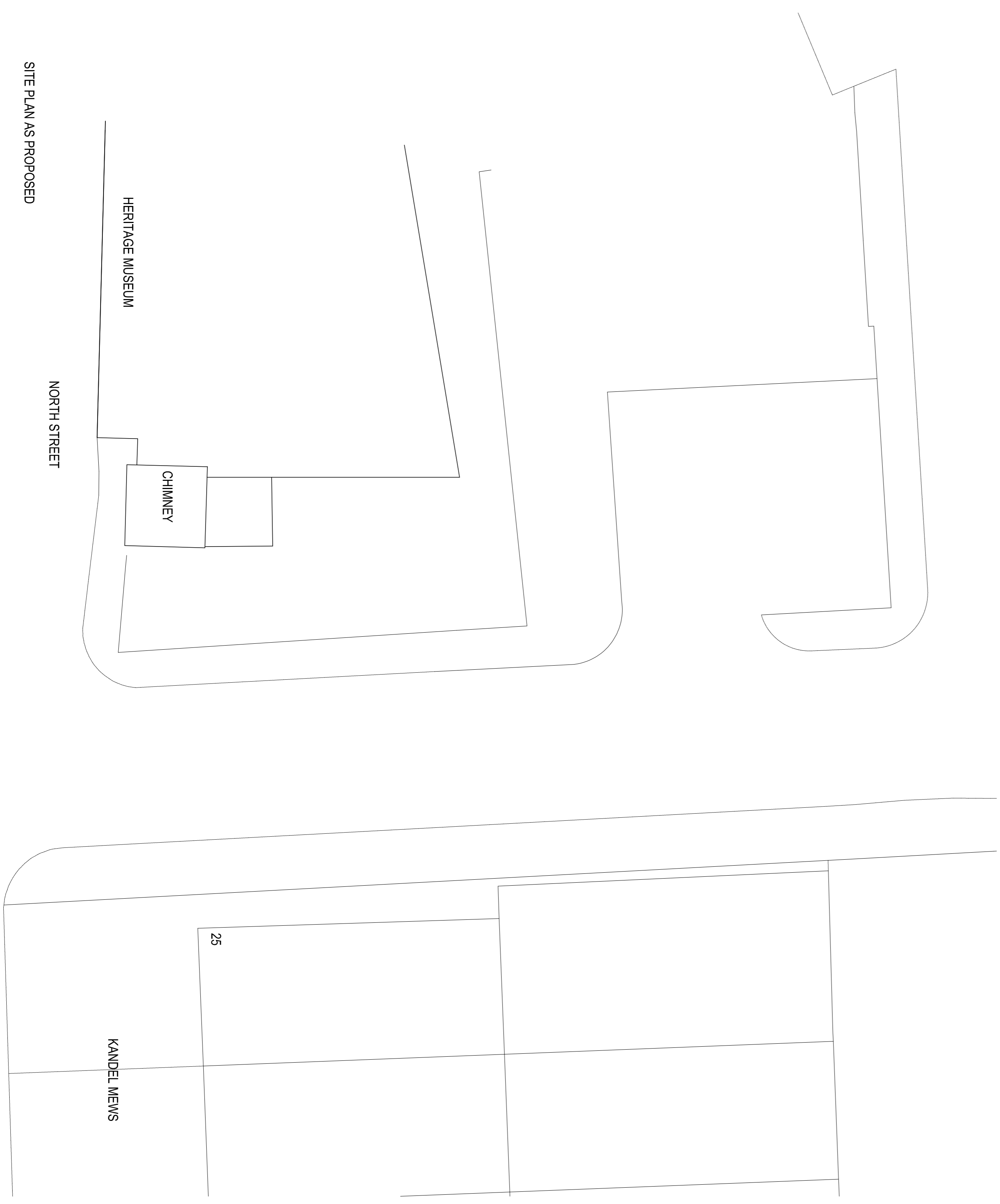
SOUTH WEST ELEVATION AS PROPOSED



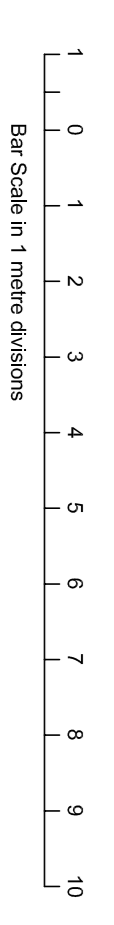
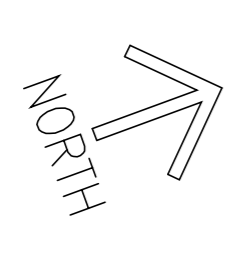
SOUTH EAST ELEVATION AS PROPOSED

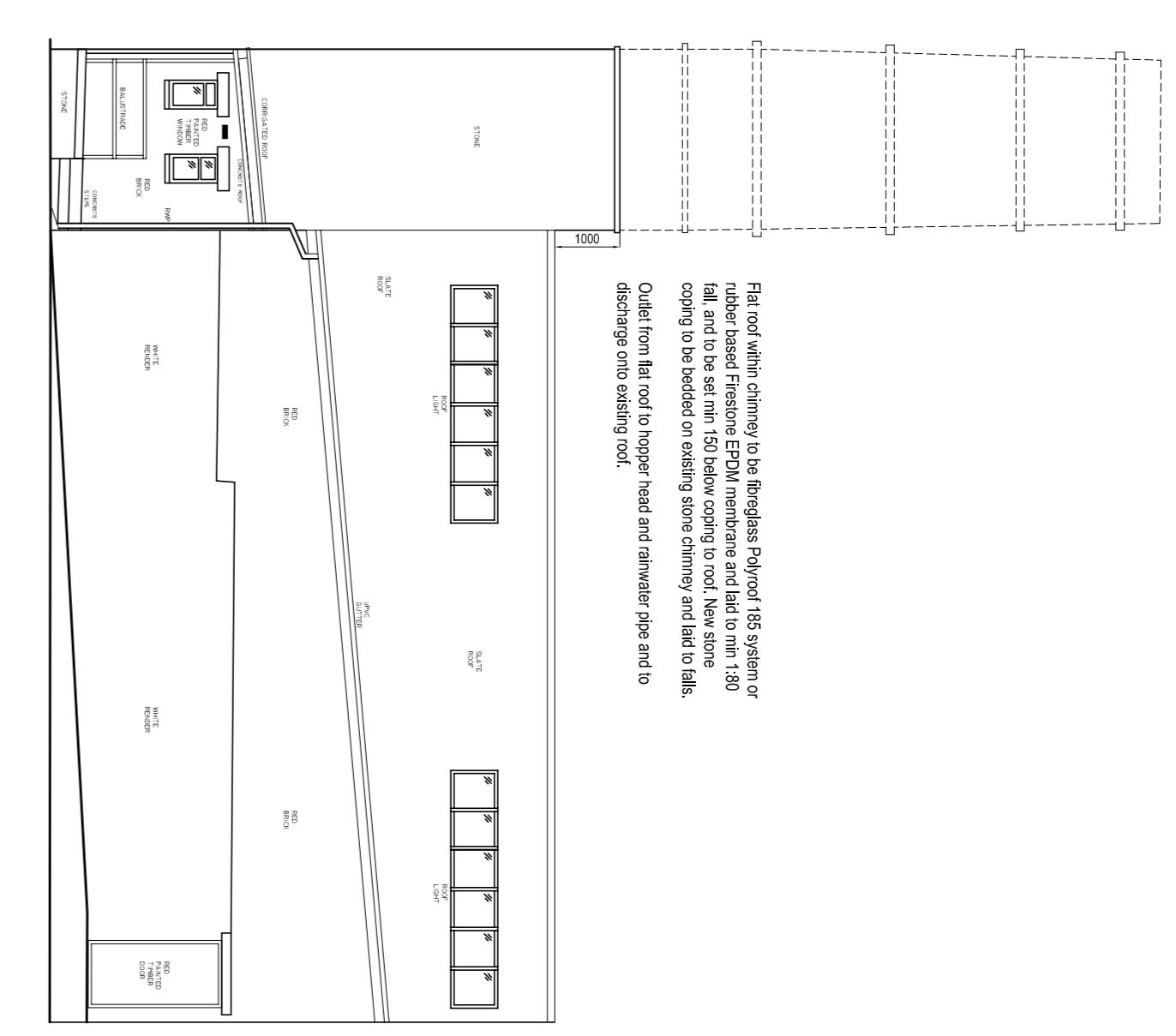

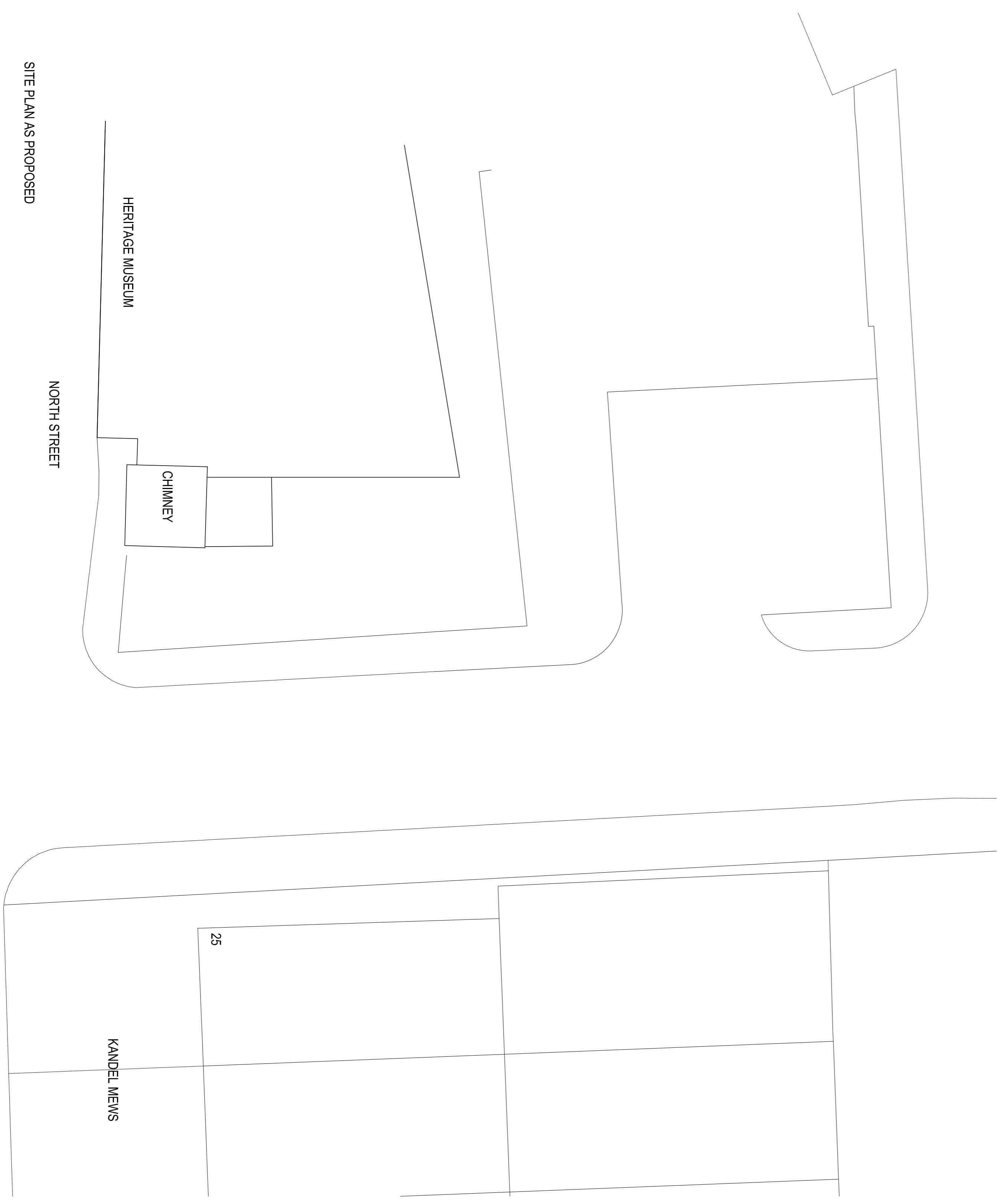
SOUTH WEST ELEVATION AS PROPOSED



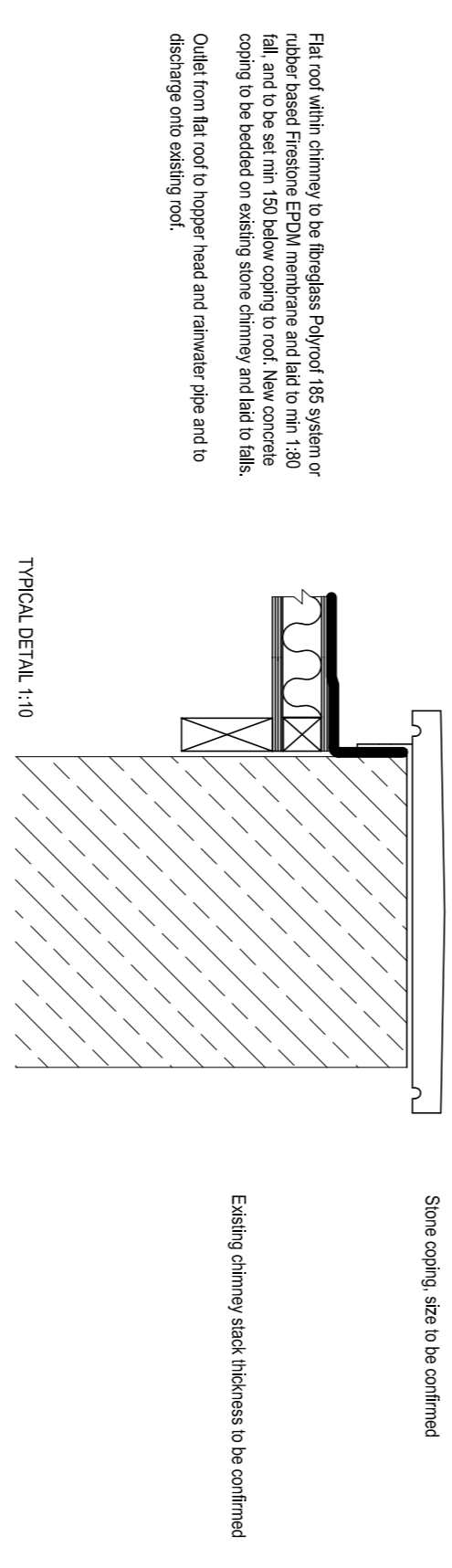
SOUTH EAST ELEVATION AS PROPOSED
