The application is of concern, as it stands, due to the proposed frequency and duration that outdoor events could happen and the fact there is no mention of noise control in Part M of the application form.

The application is for the supply of alcohol from 12.00hrs to 21.30hrs seven days a week with the licensable area including the building and the whole of the football grounds outdoor area.

The hours the premises would be open to the public would be till 22.30hrs seven days a week.

Under the current Licensing Act no licence permission is required for live and amplified/unamplified music and dance between 8.00hrs and 23.00hrs. This makes Environmental Health raise a representation as outdoor noise is a main source of noise complaint to the council causing stress and upset to neighbours if it's on a regular and frequent basis and the football club is surrounded by residential property.
