HUMAN RIGHTS

The relevant provisions of the Human Rights Act 1998 and the European Convention on Human Rights have been taken into account in the preparation of this report, particularly the implications arising from the following rights:

1. RECOMMENDATION

That Members resolve to grant planning permission subject to the conditions listed in section 10 of this report.

APPLICATION DETAILS

2. SITE

The Rising Bridge Service Station occupies a broadly triangular site just to the north of the large roundabout at the junction of Blackburn Road (A680) with the A56. On the frontage to Blackburn Road are a Shell petrol filling station and a McDonald's. To the rear of the McDonald's is a Starbuck's Drive-Thru which is currently in operation and the subject of this application.

At the time of the case officer's visit to the site some of the advertisements proposed were in situ and it is believed that all of the advertisements are now in place given the site is in full operation.

3. RELEVANT PLANNING HISTORY

2019/0433 – Full: Proposed Coffee Shop with drive thru (**Approved with conditions**).

2020/0466 – Approval of Details Reserved by Conditions 4 (noise), 5 (tree protection fencing), 7 (planting scheme), 13 (drainage management and maintenance plan) and 14 (Construction Method Statement) pursuant to Planning Permission 2019/0433 for coffee shop and drive-thru. (**Approved**).

2020/0537 – Approval of Details Reserved by Condition 10 (construction plan working method statement relating to site development earthworks and drainage) pursuant to Planning Approval 2019/0433 (Proposed Coffee Shop with drive thru). (**Approved**).

2021/0646 – Approval of Details Reserved by Condition 12 (Drainage / Surface Water) pursuant to Planning Approval 2019/0433 for a Proposed Coffee Shop with drive thru. (**Approved**).

4. PROPOSAL

The applicant seeks retrospective advertisement consent for the erection and installation of a mix of illuminated and non-illuminated advertisements within the site. A total of 17 advertisements are proposed.

The size and type of advertisements and signage proposed is detailed in the submitted 'Presentation for Stackbucks' document, received 10th February 2022.

7. REPRESENTATIONS

To accord with the General Development Procedure Order a site notice was posted and neighbour letters were sent out.

Two responses were received from those consulted, raising the following concerns:

- The location and siting of the advertisements to the rear and side of the unit serves no purposes and should be removed;
- Object to the inappropriate height and angle of the already in-situ advertising signage for Starbucks;
- The artificial illuminated signage could be considered to be a source of light pollution and or obtrusive lighting and no benefit to local residents;
- Object to the proposed installation of a drive through tannoy / public address system and the cumulative impact of this alongside the other tannoy systems in 24-hour operation;
- Proposals impact on the health and wellbeing of residents;
- Drive Thru lights on rear elevation of directly face an objector's house;

- If consent is granted then the applicant should be required to install high fencing so there is no impact on neighbouring residents.

In response to some of the matters raised above, the case officer would like to note the following:

The use of a tannoy system as part of the Drive-Thru was approved under the full application ref. 2019/0433 for the commercial unit and details of the system's methods of operation and associated noise levels were submitted and approved in writing under application 2020/0466. Furthermore, it should be acknowledged that the consent for the Drive-Thru included the following condition:

3. *The drive-through hereby permitted shall not operate other than between the hours of 0600 to 2300, and at no time shall its tannoy-system be audible at the boundary of 31 Roundhill View.*

Reason: To protect the amenities of residential neighbours.

In addition to the above, it should also be acknowledged that the application currently under consideration relates solely to the advertisements the applicant is seeking consent for. Any concerns regarding the Drive-Thru's impact on residential amenity which constitute a statutory nuisance should be raised with the Council's Environmental Health team and any breaches of planning control should be raised with the Council's Planning Enforcement team.

8. ASSESSMENT

In terms of advertisement consent the Framework states:

'Advertisements should be subject to control only in the interests of amenity and public safety, taking account of cumulative impacts' (paragraph 67).

Amenity

The new commercial building within the site is not located within a Conservation Area. A Listed Building, St. John the Evangelist, Blackburn Road, is located to the south of Blackburn Road, however, the advertisements associated to the Drive-Thru are a suitable distance from the setting of the Listed Building and are visually separated by the two other units comprising Rising Bridge Services: Shell petrol filling station and McDonalds.

Despite the site's setback from the highway, some of the advertisements would be easily seen by passers-by, nevertheless, the advertisements proposed would not detract significantly from the character of the area. The design and style of the advertisements are appropriate within the context of the site which forms part of a commercial area adjacent to the A56.

Public Safety

The Local Highway Authority have confirmed they have no objection to the proposal subject to a condition limiting the impact of any illuminated advertisement.

In terms of the proposals' impact on residential amenity in the surrounding area, the objectors' comments in respect of the advertisements proposed are noted. The Council's Environmental Health team have been consulted on the application who advised:

There are no comments from Environmental Health in relation to the lighting scheme as we are satisfied with the illuminance levels of the relevant signs/adverts, after taking into consideration the proximity of the signage to the neighbouring properties and the approved opening hours of 06:00 - 23:00.

The illuminance levels are noted in the submitted application form and the applicant has commented that "The illuminating signage will conform to the illumination guidelines as stated in the ILP guidelines, and this states for the area, the illumination and any signs will be no greater than 600 cdm²."

Subject to a condition limiting the illuminance levels of the illuminated signs proposed, it is not considered that the advertisements would have a significantly detrimental impact on residential amenity in the surrounding area given the illuminance levels would conform with illuminated guidelines.

9. SUMMARY REASON FOR APPROVAL

The signage for which consent is sought would not unduly affect public safety or amenity. It is considered that the proposal complies with the guidance within the National Planning Policy Framework and the Council's adopted Local Plan.

10. CONDITIONS

1. The development hereby consented to shall be carried out in accordance with the following documents and drawings, unless otherwise required by the conditions below:
 - Submitted Application Form (signed and dated 10th February 2022)
 - Site Location Plan
 - Presentation for Starbucks prepared by NIS SIGNS (all drawings dated 27th October 2021)
 - Illuminance Levels of Advertisements document

Reason: For the avoidance of doubt.

2. No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Reason: To accord with Regulation 14(1) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 (as amended) and for the purposes of amenity.

3. No advertisement shall be sited or displayed so as to:
 - a. Endanger persons using any highway, railway, waterway, dock, harbour or aerodrome (civil or military);
 - b. Obscure, or hinder the ready interpretation of, any traffic sign, railway signal or aid to navigation by water or air; or
 - c. Hinder the operation of any device used for the purpose of security or surveillance or for measuring the speed of any vehicle.

Reason: To accord with Regulation 14(1) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 (as amended) and for the purposes of public safety.

4. Any advertisement displayed, and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

Reason: To accord with Regulation 14(1) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 (as amended) and for the purposes of amenity.

5. Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a condition that does not endanger the public.

Reason: To accord with Regulation 14(1) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 (as amended) and for the purposes of public safety.

6. Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.

Reason: To accord with Regulation 14(1) of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 (as amended) and for the purposes of amenity and public safety.

7. Any illuminated advertisement shall be designed so that:

- The level of illuminance shall be in strict accordance with the Illuminance Levels of Advertisements document
- No part of the source of the illumination shall at any time be directly visible to users of adjacent adopted highway.
- Static illumination is provided, and the sign shall not feature intermittent or flashing lights.
- Moving features are not provided.

Reason: In the interest of highway safety to avoid glare, dazzle, or distraction to passing highway users and neighbour amenity.

INFORMATIVE

1. The proposal complies with the development plan and would improve the economic, social and environmental conditions of the area. It therefore comprises sustainable development and the Local Planning Authority worked proactively and positively to issue the decision without delay. 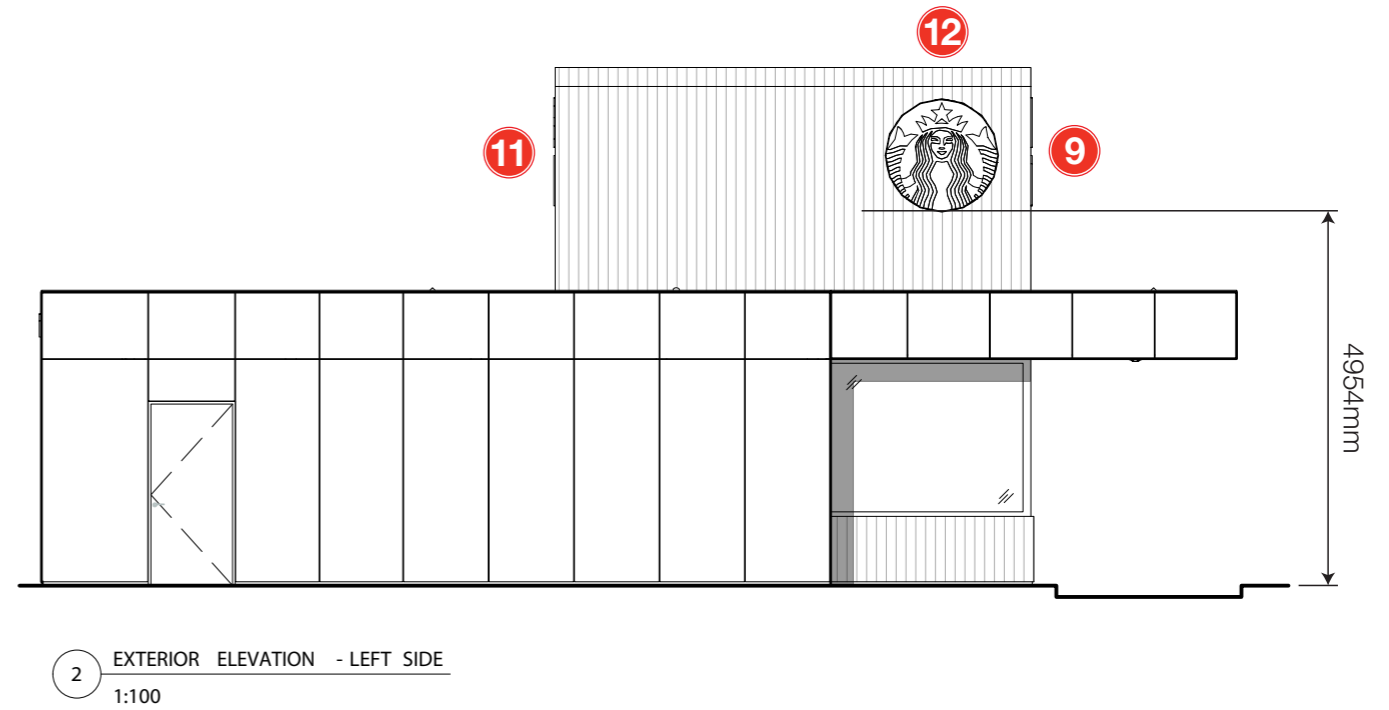
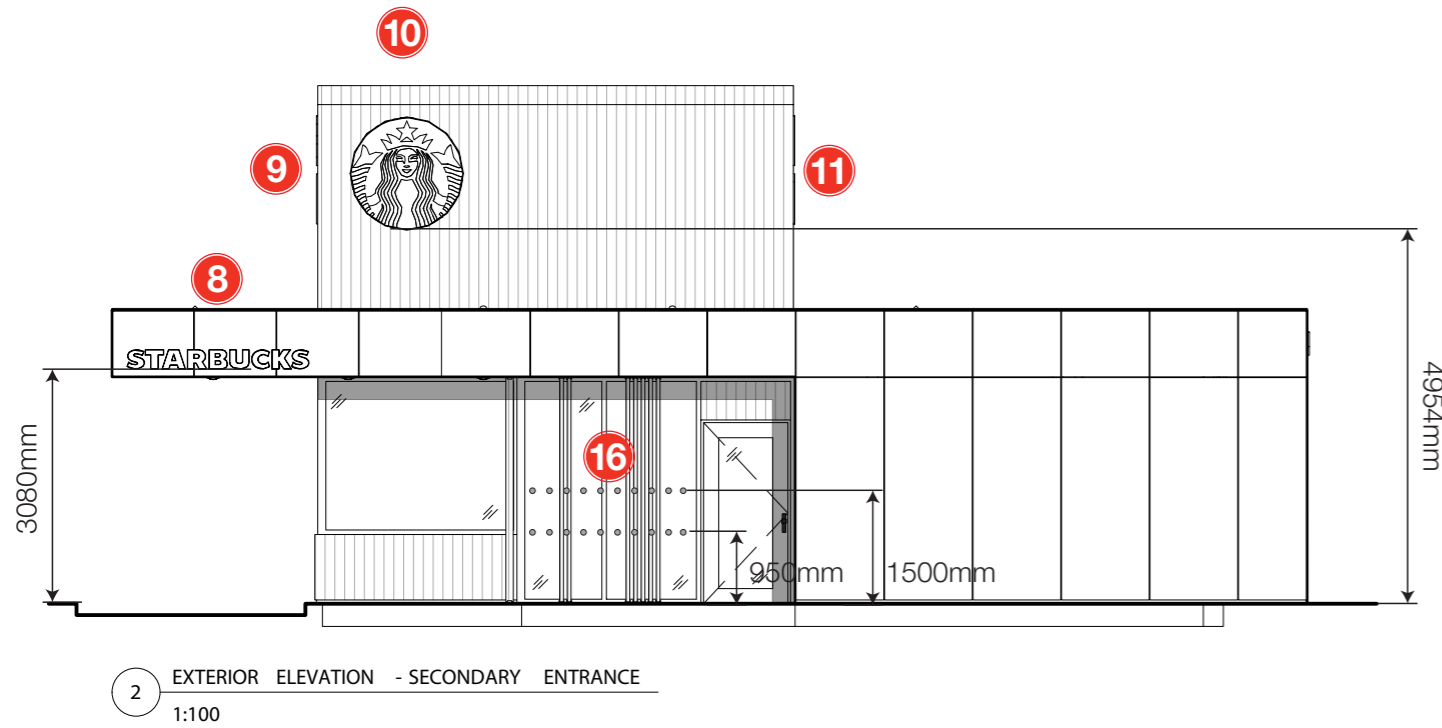
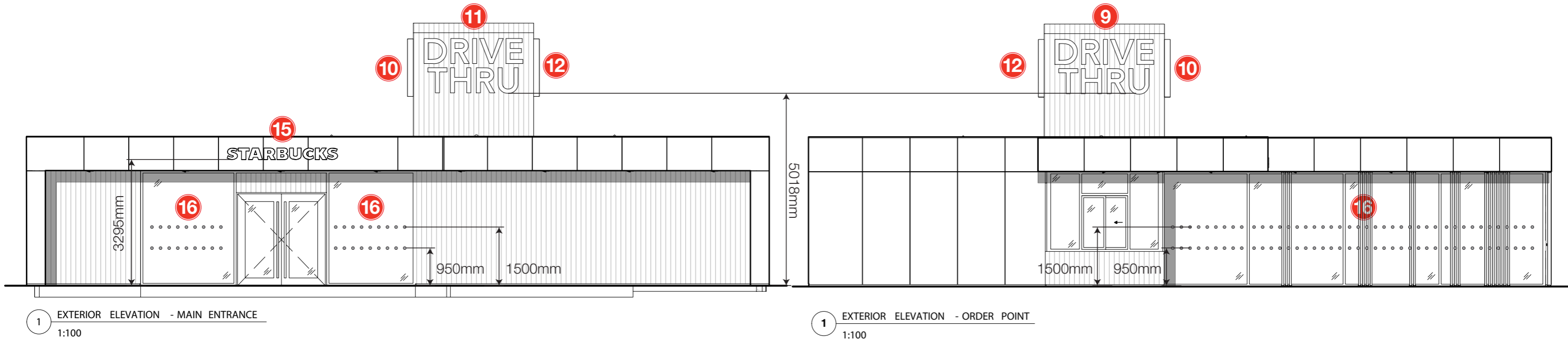
Full Site Plan Scale 1:500
