1. REASON FOR REFERRAL

1.1 To advise members of an application for the grant of a premises licence under Section 17 of the Licensing Act 2003.

2. RECOMMENDATIONS

2.1 It is recommended that members determine the application in accordance with the provisions of the Licensing Act 2003.

3. LICENSING OBJECTIVES

- 3.1 Members are reminded of the Licensing objectives as follows:
 - The prevention of crime and disorder;
 - Public Safety;
 - The prevention of public nuisance; and
 - The protection of children from harm

4. THE APPLICATION

- 4.1 An application for the grant of a premises licence was received from Tiki Tiger Limited on 30th June 2022. The application is appended at **Appendix A**.
- 4.2 The application was properly advertised in accordance with the requirements of the Act.
- 4.3 The application proposes:

Recorded Music (Indoors), Sale of Alcohol (Both)

Between 0900 hours and 0200 hours Sunday to Thursday Between 0900 hours and 0400 hours Friday and Saturday

An additional hour on the day that British Summertime commences.

Between 0900 hours and 0400 hours on Sundays which precede UK Bank Holidays, Maundy Thursday, Halloween, the Friday preceding Christmas Day, Christmas Eve, Boxing Day and New Year's Eve.

Late Night Refreshment (Indoors)

Between 2300 hours and 0200 hours Sunday to Thursday Between 2300 hours and 0400 hours Friday and Saturday

Hours premises are open to the public:

Between 0900 hours and 0230 hours Sunday to Thursday Between 0900 hours and 0430 hours Friday and Saturday

An additional hour on the day that British Summertime commences.

Between 0900 hours and 0400 hours on Sundays which precede UK Bank Holidays, Maundy Thursday, Halloween, the Friday preceding Christmas Day, Christmas Eve, Boxing Day and New Year's Eve.

- 4.4 Whilst the application initially proposed that the DPS would be Matthew Rees, this has subsequently been varied to Michael Long and this variation received no objections from the Police.
- 4.5 The applicant has detailed the steps they intend to take to promote the licensing objectives and these steps will be translated into conditions on the licence, if granted. These conditions are appended at **Appendix B**.

5. BACKGROUND

- 5.1 The premises currently holds a premises licence authorising recorded music, late night refreshment and the sale of alcohol. A copy of this licence is appended at **Appendix C**.
- 5.2 This application was submitted in October 2019 and following the receipt of relevant representations, the matter was determined at a hearing on 20th November 2019.
- Members will already have noticed that the conditions imposed on this licence are mirrored in the application they are asked to consider. There is only one condition imposed on this licence that hasn't been included in the operating schedule of the application, which is likely to be an oversight rather than a deliberate omission. This condition is highlighted with a border in Appendix B and relates to a dispersal policy.
- 5.4 Member will also have noted that the difference in hours between the current licence and the application amount to an additional 2 hours on Fridays and Saturdays.
- 5.5 There is also an increase which relates only to non-standard timings as outlined in the application (these non-standard timings are not currently accommodated for on the current licence).

6. RESPONSIBLE AUTHORITIES

6.1 Environmental Health have submitted a representation to this application and this is appended at **Appendix D**.

7. REPRESENTATIONS

- 7.3 All of these representations have come from residents of Parramatta Street.
- 7.4 A location plan is appended at **Appendix J**.

8. OPTIONS

- 8.1 Members should always consider whether concerns raised can be overcome by the addition of conditions before refusing an application.

 - 1. To grant the licence subject to:

 - b) any mandatory conditions which must be included in the licence,
 - 2. To exclude from the scope of the licence any of the licensable activities to which the application relates,
 - 3. To refuse to specify a person in the licence as the premises supervisor;
 - 4. To reject the application.

10. CRIME AND DISORDER

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

Upon commencement of their employment, all staff who are involved in the sale of alcohol will be trained in relation to the licensing objectives so as to reduce crime and disorder, promote public safety, prevent public nuisance and promote the protection of children from harm. Such training will be documented and will be made available to an authorised officer upon request.

Refresher training will be provided at least once every six months and such training will be documented and made available to an authorised officer upon request.

All training records shall be retained for a rolling period of two (2) years.

b) The prevention of crime and disorder

The premises will be an active member of any local "pub watch" or equivalent scheme where such a scheme exists.

A CCTV system shall be installed at the premises and will meet the following criteria:

- The system will display on any recording the time and date of said recording;
- The system will be recording whenever the premises is open to the public;
- Any recordings will be retained for a minimum of 28 days after they are made and will be produced to an authorised officer upon request; and,
- The CCTV will capture all public areas of the premises, with the exception of the toilets.

Signage in a font size of 16 or larger alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.

A competent person trained in the use of and operation of the CCTV will be in attendance at the premise at all times that licensable activities are taking place. This person will be able to fully operate the CCTV system and be able to download data in a recognised format upon request.

A register of all incidents in relation to crime and disorder and ejections from the premises must be maintained at the premises and made available upon request to an authorised officer upon request.

Prior to any occasion on which licensable activities are to be carried on at the premises, the designated premises supervisor or another person nominated by them in writing shall be responsible for carrying out a written risk assessment to determine whether door supervisors are required. An appropriate number of door supervisors will be utilised in accordance with said risk assessment and as a minimum, whenever the premises is open to the public, one door supervisor will be utilised from midnight to the end of trading on Fridays and Saturdays.

c) Public safety

Any sales of alcohol knowingly made for consumption off the premises will be made in a sealed container.

d) The prevention of public nuisance

The Shift Manager or other person nominated in writing by the Licence Holder will be responsible for ensuring that the area immediately outside the building is swept and tidied of litter at the end of trading on each day.

Signage in a font size of 18 or larger must be displayed at the main public exit and shall request that customers leave the premises and the area quickly and quietly.

All external doors and windows must remain closed at all times that regulated entertainment takes place from the premises, save for access and egress.

On at least one occasion between 00:00 hours and 01:00 hours on Fridays and Saturdays, the manager or other person nominated in writing for this purpose, shall conduct a noise assessment of the noise emanating from the premises and such assessment shall take place from outside of number 7 and number 10 Parramatta Street, Rawtenstall, if in the Assessors reasonable view, the noise is likely to cause a nuisance to local residents, remedial action must be taken.

A written record must be maintained at the premises detailing the time of the noise assessment, the identity of the person undertaking the assessment, the result of the assessment, and any remedial action taken, Such records will be made available to an Authorised Officer upon request.

e) The protection of children from harm

Persons under the age of 18 years shall not be permitted on the premises after 23:00 each day.

All persons purchasing alcohol who appear to be under the age of 25 years shall be required to produce proof of age by way of one of the following:

- A UK Photocard Driving Licence;
- A Passport;
- Official ID card issued by HM Forces or EU bearing a photograph and the date of birth of the holder:
- Any other form of identification agreed with a representative of the Police Licensing Unit.

All staff who are involved in the sale of alcohol will be trained in relation to the "Challenge 25" policy upon the commencement of their employment amd must undertake refresher training at least once every twelve months. Said training will be documented and will be made available to an authorised officer upon request. Such records will be retained for a rolling period of two (2) years.

Upon commencement of their employment, all staff who are involved in the sale of alcohol will be trained in relation to the licensing objectives so as to reduce crime and disorder, promote public safety, prevent public nuisance and promote the protection of children from harm. Such training will be documented and made available to an Authorised Officer upon request.

Refresher training will be provided at least once every six months and such training will be documented and made available to an Authorised Officer upon request.

All training records shall be retained for a rolling period of two (2) years.

The premises will be an active member of any local "pub watch" or equivalent scheme where such a scheme exists.

A CCTV system shall be installed internally and externally at the premises and must meet the following criteria:

- The system will display on any recording the time and date of the said recording;
- The system will record whenever the premises is open to the public;
- Any recording will be retained for a minimum of 28 days after they are made and will be produced to an Authorised Officer upon request;
- The CCTV will capture all public areas of the premises, with the exception of the toilets.

Signage in font size of 16 or larger alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.

A competent person trained in the use of an operation of the CCTV will be in attendance at the premises at all times that licensable activities are taking place. This person must be able to fully operate the CCTV system and be able to download the data in a recognized format when requested.

A register of all incidents in relation to crime and disorder and ejections from the premises must be maintained at the premises and made available to an Authorised Officer upon request.

Prior to any occasion on which licensable activities are to be carried on at the premises, the designated premises supervisor or other person nominated in writing by them shall be responsible for carrying out a written risk assessment to determine whether door supervisors are required. An appropriate number of door supervisors will be utilised in accordance with the written risk assessment and as a minimum, whenever the premises is open to the public, one door supervisor will be utilised from midnight to the end of trading on Fridays and Saturdays.

All sales of alcohol for consumption off the premises must be made in a sealed container.

The Shift Manager or other person nominated in writing by the Licence Holder will be responsible for ensuring that the area immediately outside the building is swept and tidied of litter at the end of trading on each day.

Signage in font size of 18 or larger must be displayed at the main public exit and shall request customers to leave the area quickly and quietly.

All external doors and windows must remain closed at all times that regulated entertainment takes place from the premises, save for access and egress.

There shall be at the premises, a written dispersal policy designed to encourage customers to leave the venue and the areas quickly and quietly.

On at least one occasion between 0000 hours and 0100 hours on Fridays and Saturdays, the manager or other person nominated in writing for this purpose, shall conduct a noise assessment of the noise emanating from the premises and such assessment shall take place from outside of number 7 and number 10 Parramatta Street, Rawtenstall, if in the Assessors reasonable view, the noise is likely to cause nuisance to local residents, remedial action must be taken.

A written record must be maintained at the premises detailing the time of the noise assessment, the identity of the person undertaking the assessment, the results of the assessment and any remedial action taken, such records will be made available to an Authorised Officer upon request.

Persons under the age of 18 years shall not be permitted on the premises after 2300 hours each day.

All persons purchasing alcohol who appear to be under the age of 25 years shall be required to produce proof of age by way of the following:

- A UK photo card driving licence
- Passport
- Official ID card issued by HM Forces or EU bearing a photograph and the date of birth of the holder.
- Any other form of identification agreed with a representative of the Police Licensing Unit.

All staff involved in the sale of alcohol will be trained in relation to the "Challenge 25" policy and must undertake refresher training at least once every twelve months. Such training shall be documented and made available to an Authorised Officer upon request. Such records shall be retained for a rolling period of two (2) years.

Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the premises licence at a time when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or their licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in the above paragraph:

- a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- b) "permitted price" is the price found by applying the formula-

P=D+(DxV)

where-

- i. P is the permitted price,
- ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - i. the holder of the premises licence,
 - ii. the designated premises supervisor (if any) in respect of such a licence, or
 - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar

activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:

- a) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- a) a holographic mark, or
- b) an ultraviolet feature.

The responsible person must ensure that:

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:
 - i. beer or cider: ½ pint;
 - ii. gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii. still wine in a glass: 125 ml;
- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the

customer is made aware that these measures are available.

Where a premises licence authorises the exhibition of films:

Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.

Where:

- a) the film classification body is not specified in the licence, or
- b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

In this section:

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984.

Where a premises licence includes a condition that an individual must carry out a security activity:

Each individual in the premises to carry out a security activity must be licensed by the Security Industry Authority unless the premises or part of the premises where they are present are being used are wholly or mainly a restaurant or guest house, theatrical performances, plays or a Gaming Licence is for the time being in force in respect of those premises.

- The CCTV will capture all public areas of the premises, with the exception of the toilets.

Signage in font size of 16 or larger alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.

A competent person trained in the use of an operation of the CCTV will be in attendance at the premises at all times that licensable activities are taking place. This person must be able to fully operate the CCTV system and be able to download the data in a recognized format when requested.

A register of all incidents in relation to crime and disorder and ejections from the premises must be maintained at the premises and made available to an Authorised Officer upon request.

Prior to any occasion on which licensable activities are to be carried on at the premises, the designated premises supervisor or other person nominated in writing by them shall be responsible for carrying out a written risk assessment to determine whether door supervisors are required. An appropriate number of door supervisors will be utilised in accordance with the written risk assessment and as a minimum, whenever the premises is open to the public, one door supervisor will be utilised from midnight to the end of trading on Fridays and Saturdays.

All sales of alcohol for consumption off the premises must be made in a sealed container.

The Shift Manager or other person nominated in writing by the Licence Holder will be responsible for ensuring that the area immediately outside the building is swept and tidied of litter at the end of trading on each day.

Signage in font size of 18 or larger must be displayed at the main public exit and shall request customers to leave the area quickly and quietly.

All external doors and windows must remain closed at all times that regulated entertainment takes place from the premises, save for access and egress.

There shall be at the premises, a written dispersal policy designed to encourage customers to leave the venue and the areas quickly and quietly.

On at least one occasion between 0000 hours and 0100 hours on Fridays and Saturdays, the manager or other person nominated in writing for this purpose, shall conduct a noise assessment of the noise emanating from the premises and such assessment shall take place from outside of number 7 and number 10 Parramatta Street, Rawtenstall, if in the Assessors reasonable view, the noise is likely to cause nuisance to local residents, remedial action must be taken.

A written record must be maintained at the premises detailing the time of the noise assessment, the identity of the person undertaking the assessment, the results of the assessment and any remedial action taken, such records will be made available to an Authorised Officer upon request.

Persons under the age of 18 years shall not be permitted on the premises after 2300 hours each day.

All persons purchasing alcohol who appear to be under the age of 25 years shall be required to produce proof of age by way of the following:

- A UK photo card driving licence
- Passport
- Official ID card issued by HM Forces or EU bearing a photograph and the date of birth of the holder.
- Any other form of identification agreed with a representative of the Police Licensing Unit.

All staff involved in the sale of alcohol will be trained in relation to the "Challenge 25" policy and must undertake refresher training at least once every twelve months. Such training shall be documented and made available to an Authorised Officer upon request. Such records shall be retained for a rolling period of two (2) years.



We write in response to your above consultation request.

Environmental Health believes that the granting of this application, in its current form, will undermine the prevention of public nuisance licensing objective and therefore we raise an objection to this application for a new premises licence at Tiki Tiger, 28 Bury Road, Rawtenstall BB4 6AA on the prevention of public nuisance ground.

The applicant seeks a premises licence for the above premises to sell a range of alcoholic and non-alcoholic drinks, with the following opening hours:

Sunday to Thursday: 09.00hrs to 02.30hrs Friday and Saturday: 09.00hrs to 04.30hrs

Although Tiki Tiger is located within the town centre boundary, there are also residential properties in close proximity on Parramatta Street, Queen Street and on Bury Road.

Environmental Health have had a loud music complaint from the Tiki Tiger however it was unsubstantiated. The nature of the area means that it can be difficult for complainants to pinpoint exactly which premises are causing the nuisance and extending the hours will detrimentally impact the area in terms of noise.

In the main there have been numerous complaints from nearby residents about people noise in the streets in the vicinity including persons arguing, fighting, screaming, shouting and singing going on past 2am when the bars currently close.

"Rossendale will have strong communities with an enhanced environment and heritage.

It will be an attractive place to live where tourists visit and employers invest."



There have also been reports that the back street between Tiki Tiger and Blind Tiger leading to Parrammatta Street is used as a toilet and people have been seen urinating on it.

There have also been reports of resident's cars being damaged late at night.

Environmental Health feel the extension of hours until 02.30hrs on Sunday to Thursday and 04.30hrs on Friday and Saturdays will just prolong and exacerbate the public nuisance from clientele of the bars that residents already have to deal with.

The steps the applicant has listed to prevent public nuisance are suitable at the premises, the issue is with the anti-social behaviour and public nuisance caused by some drinkers when they have left the premises which then becomes a Police matter.

We are concerned that if this premises licence is granted it will lead to an intensification of the area as a very late night/early morning drinking location. If this licence was to be granted, other nearby premises would no doubt follow with applications and we foresee a problem where people noise, asb and public nuisance on the street would become a more serious cause for concern.

There is also no designated taxi rank outside the bars in this area of the town meaning that patrons tend to walk past and through the residential streets to get to a taxi rank.

We confirm that these are the reasons that Environmental Health raise an objection to this application and we are working proactively and on behalf of residents in the area who may not be aware of this application

Several families reside on both Parramatta Street and Queens Street, with young children. Also, these children play in the street and this should be considered a safe space. Children having to walk through or even be near urine, vomit and discarded drugs paraphernalia is completely wrong and adding additional hours to this will only make the existing problem worse. Again we also have to consider the impact this will have on the vulnerable young adults living in the care home on Queens Street. They should not be exposed to this type of behaviour and certainly should not be exposed to increased levels of this

As discussed, the issues created by the local drinking premises are a significant and ongoing problem for local residents. However, the issues are at least mitigated slightly by the fact there is an end to it. Extending the licence to the early hours of the morning will significantly increase the problems we have faced for so long.

We also have to consider the president that this will set for the other bars in the same area. Not long-ago Blind Tiger applied for a late licence following the opening of Revival Night Club. Local residents explained the issues and represented themselves during the application process and gratefully the application was rejected. However, if one bar is granted an extended licence, I have no doubt that other bars will follow which will again further increase the issues associated with these venues. However, residents will have little support in appealing against this when they can reference that their competition have already been granted a licence.

This is a residential area and expecting residents (including children and vulnerable adults) to be subject to this activity until the early hours of the morning is completely wrong. Our houses are meant to be safe and enjoyable places to be, not the toilet for bars to have night club opening times. These properties are our investments and our pensions and allowing this sort of licence will significantly impact their value as no one wants to live next to a nightclub.

I was also shocked by how Tiki Tiger displayed the application document as in my option this should be visible from the main road and not the alley way. I was also surprised the owners of Tiki Tiger did not consult with local residents before applying for the licence extension. Assuming that the owners of Tiki Tiger are still the owners of Tiger Lounge, they made a big point of consulting with the residents when applying for the original licence, going so far as to invite the residents for a discussion on how this could work. It seems very clear that the owners are aware that this application would cause objections from local residents and decided not to consult with them as it would not support them. If find this particularly frustrating after supporting their previous licence application after speaking with them directly.
