1. REASON FOR REFERRAL

1.1 To advise members of an application for the grant of a premises licence under Section 17 of the Licensing Act 2003.

2. RECOMMENDATIONS

2.1 It is recommended that members determine the application in accordance with the provisions of the Licensing Act 2003.

3. LICENSING OBJECTIVES

- 3.1 Members are reminded of the Licensing objectives as follows:
 - The prevention of crime and disorder;
 - Public Safety;
 - The prevention of public nuisance; and
 - The protection of children from harm

4. THE APPLICATION

- 4.1 An application for the grant of a premises licence was received from Thyme Wine & Cocktail Bar Limited on 7th July 2023. The application is appended at **Appendix A**.
- 4.2 The applicant is a registered private limited company under company number 14932847.
- 4.3 The Directors are listed as Mr Gabi A Webbe and Mary Webbe.
- 4.4 The application proposes:

Live music (Indoors):

Between 1200 hours and 0000 hours Friday and Saturday

Recorded music (Indoors):

Between 1200 hours and 0000 hours Friday and Saturday

The sale by retail of alcohol:

Between 1200 hours and 2300 hours Monday to Wednesday

Between 1200 hours and 2200 hours Thursday

Between 1200 hours and 0000 hours Friday and Saturday

Between 1200 and 2200 hours Sunday

The sale shall be for consumption ON and OFF the premises.

- 4.5 Every premises licence that authorises the sale of alcohol must specify a DPS. This will normally be the person who has been given day to day responsibility for running the premises by the premises licence holder.
- 4.6 The application proposes that the designated premises supervisor will be Mr Gabi A Wehbe who is the holder of a personal licence issued by Burnley Borough Council.
- 4.7 The applicant has detailed the steps they intend to take to promote the licensing objectives and these steps will be translated into conditions on the licence, if granted.
- 4.8 These conditions are appended at **Appendix B**.

5. BACKGROUND

- 5.1 The premises subject to this application was until recently an accounting office and most recently, a domiciliary home care provider.
- 5.2 This premises has not previously been licensed.
- 5.3 A plan showing the location of the premises, other on licensed premises, the location of representations and other properties is appended at **Appendix C**.
- 5.4 Whilst the regimes are properly segregated, members should note that a planning application has been submitted for the premises. At the time of writing, the application has not yet been accepted and declared valid.
- 5.5 Members should also note that the planning application will properly consider those elements that licensing cannot, for example, parking, and will consider the use of the land rather than just the licensable activities that licensing is restricted to.

6. RESPONSIBLE AUTHORITIES

6.1 There have been no representations from the responsible authorities.

7. REPRESENTATIONS

- 7.1 There have been 3 representations from "other persons". Two of these representations are from people living in the vicinity of the premises and they are appended at **Appendix D**.
- 7.2 These representations have regard to noise and disturbance.
- 7.3 The representations also concern issues which cannot lawfully be considered by this sub-committee such as parking and problems, particularly historical problems with other premises in the locality.

- 7.4 The representation also refer to the necessity of the business. Members are reminded that "need" is a matter for the Planning Authority and for the market (market forces).
- 7.5 The third representation is from the Goodshaw ward councillor and is appended at **Appendix E**.

8. OPTIONS

- 8.1 Members should always consider whether concerns raised can be overcome by the addition of conditions before refusing an application.
- 8.2 Members should consider the application, the representations and all submissions made and must take the steps below (if any) as it considers appropriate for the promotion of the licensing objectives. The steps are:
 - 1. To grant the licence subject to:
 - the conditions in the operating schedule modified to such extent as the Authority considers appropriate for the promotion of the licensing objectives, and
 - b) any mandatory conditions which must be included in the licence,
 - 2. To exclude from the scope of the licence any of the licensable activities to which the application relates,
 - 3. To refuse to specify a person in the licence as the premises supervisor;
 - 4. To reject the application.

9. POLICIES TO CONSIDER

- Rossendale Borough Council's Statement of Licensing Policy effective 20th March 2019.
 - Guidance issued under Section 182 of the Licensing Act 2003.

10. CRIME AND DISORDER

- 10.1 Section 17(1) of the Crime and Disorder Act 1998 places a duty on the Local Authority to have due regard to the likely effect of the exercise of these functions on preventing in its area, the following;
 - crime and disorder;
 - misuse of drugs alcohol and other substances; and
 - re-offending.

All staff suitably trained for their job. Training will be written and under constant review and available to relevant responsible authority when call upon. No member will be permitted to sell alcohol until successfully completed this training.

Training consists of – penalties, age of policies, signs of drunkenness and licensing objectives.

b) The prevention of crime and disorder

CCTV system shall be installed Entrance / Exit.

CCTV to record where alcohol is kept and consumed all recording shall be stored a min of 31 days. Recording available on request, sign of CCTV for customers.

Drink promotions shall be risk assessed to ensure the promotion is not irresponsible.

c) Public safety

All exit areas shall be kept clear. Exit doors shall be available without the use of key, card or code. Regular checks and maintenance shall be carried out on all equipment, electrical installations, emergency lighting and fire alarms. The licence holder shall ensure that a suitable fire risk and emergency plan is available.

d) The prevention of public nuisance

Signage shall be displayed on the premises requesting that the customer take home any alcohol purchased and not consumed in the streets. No collection of refuse between 19:00-07:00. Deliveries shall take place between 07:00-19:00 frontage shall be regularly monitored to keep clean of litter.

e) The protection of children from harm

The licensee to adopt a "challenge 25" policy where all customers who appear to be under the age of 25 and attempt to purchase alcohol or other under age restricted products are asked for proof of age. The licensee to prominently display notices advising customers of the "challenge 25" policy. The following proof of age are the only one to be accepted:

Proof of age card bearing the pass hologram logo, passport or UK photo driving licence.

During the hours of operation of the premises, the licence holder shall ensure sufficient measures are in place to remove and prevent litter or waste arising or accumulating from customers in the area immediately outside the premises, and that this area shall be swept and or washed, and litter and sweepings collected and stored in accordance with the approved refuse storage arrangements by close of business.

Condition 8:

All persons purchasing alcohol who appear to be under the age of 25 years shall be required to produce proof of age by way of the following:

- A recognised proof of age card accredited under the British Retail Consortiums Proof of Age Standards Scheme (PASS)
- Photo driving licence

Dear Sir/Madam

I wish to object to the application from Gabi Adrian Wehbe to obtain a license to open 564 Burnley Road, Crawshawbooth as a cocktail bar, which will sell and supply of alcohol from 12.00 – 23.00 (Monday, Tuesday, Wednesday) 12.00 – 22.00 (Thursday & Sunday) and 12.00 – midnight (Friday and Saturday). And to provide live and recorded music 12.00 – midnight (Friday and Saturday).

My objection is based on my concern that this new licence will increase the possibility of public nuisance for the many dwellings nearby. I am particularly concerned about noise nuisance given the proximity to residential property, and I note from the application documents, that there is no reference as to how the licence applicant intend to satisfy the requirements of the four licencing objectives:

- Prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- Protection of children from harm

I find this omission particularly significant as the intended licensed premises has multiple residential dwellings adjacent to its location: to the rear on Mansion House Buildings, to the side on Co-operation Street, and opposite on Burnley Road and Post Office Street. The residents of some of these locations have experienced previous noise issues with another licensed premises within very close proximity to the location over a protracted period (5yrs), and which required the involvement of Police to reach a suitable resolution.

564 Burnley Road is probably the largest commercial building in the village. The floor space is significant. Siting a cocktail bar and live music venue could result in large number of people visiting the venue. On leaving the bar/ club, late at night there will be noise.

Given the proximity to residential property I am also concerned that the council will receive complaints which will require significant staff resources to manage residents' concerns against the venue activity.

I am also concerned that, again given the proximity to residential property that sound levels will be sufficient to take legal action against the club, similarly to Night and Day, a music venue in the Northern Quarter, Manchester. The City Council is currently embroiled in a legal battle with the venue owners. Enforcement/ legal action has been ongoing with this for a number of years.

The building is self-contained and does not appear to have a yard area or any separate outside space to contain refuse, empty bottles etc.

There is also no car park linked to the premises.

Currently there are four drinks venues in Crawshawbooth – the Masons, The Black Dog, Liz's Bar and the White Bull. A new, large music venue in the village runs the risk of changing the nature of what is relatively small village. On a larger scale Monton in Salford has almost been taken over by restaurants and cafes, and whilst residents clearly want access to great places to eat and drink there is a limit to what a village can reasonably stand.

I and others in my ward are of the view that RBC as the licensing authority should **not** grant a new premises licence, without first hearing supporting consideration of how the business intend to deal the licensing objectives outlined above and with associated issues such as:

- Proposed collection/disposal of bottles, cans, and glass to minimise noise when items put out for collection/collected.
- Delivery arrangements for stock.
- Car Parking proposal.
- Smoking/Vaping policy, which includes a clearly identified proposed/suitable location.
- Dispersal policy for patrons upon closing.
- Clarification over whether the live music is to be amplified or not.
- Noise management plan.

I respectfully submit that if this venue were subject to assessment using a 'Risk Assessment for Indoor and Outdoor Venues Involving Music', then it would rate 'High' due to its proposed activities, times, and location.

Put simply, if the application is granted in its current proposed format, the authority would subsequently be expected to carry out its statutory duties when investigating complaints made under s79(g) Environmental Protection Act 1990: i.e., noise emitted from premises so as to be prejudicial to health or a nuisance, as mentioned above in the case of MCC and Night & Day, and without appropriate conditions in place it is likely the noise levels will meet the threshold for enforcement action.

I would be grateful if the Licensing team would consider my objection.
