## 1. RECOMMENDATION

### 2. EXECUTIVE SUMMARY

- Amending the Terms of Reference of the Local Plan Steering Group will allow more flexibility and will allow the group to seek a wider range of views as and when required.
- A new Roll of Honour procedure will allow nominations to be progressed.

### 3. BACKGROUND

# **Local Plan Steering Group**

3.1 At the previous meeting of the Local Plan Steering Group it was recommended to expand the group as its current composition did not achieve representation from all sections of the borough.

### **Roll of Honour**

3.2 A councillor has requested the Roll of Honour procedure be reviewed and updated to enable nominations to be progressed, as the current procedure is no longer functional.

#### 4. DETAILS

# **Local Plan Steering Group**

- 4.1 The current Local Plan Steering Group is consists of 5 councillors. The group is politically balanced and includes the Lead Member and Chair of the Development Control Committee.
- 4.2 At the January meeting of the steering group it was recommended to expand the group to enable views to be sought from each section of the borough.
- 4.3 To allow a flexible approach, a more fluid membership has been proposed so that the group can be expanded where a wider range of views are to be sought (so long as this is in keeping with the political balance).
- 4.4 The suggested amendments to the Terms of Reference detailed at appendix A will enable the Local Plan Steering Group to achieve more flexibility as and when required, and will keep the wording consistent with that of the Cross Party Working Group.

#### Roll of Honour

- 4.5 The current procedure entails putting nominees forward as part of the Community Awards to be considered for the Roll of Honour title, however the Community Awards have not taken place for some considerable time.
- 4.6 A councillor has requested the Roll of Honour procedure be updated to enable people who have made outstanding voluntary community contributions to be put forward more effectively.
- 4.7 The suggested amendments to the procedure attached at appendix A will allow for a more efficient procedure to be introduced.

4.8 Governance Working Group were consulted on the changes at their meeting on 12<sup>th</sup> February where they made the following recommendation:

### LOCAL PLAN REVIEW STEERING GROUP

Number of councillors: 5 Quorum: 3

# Composition

- Membership of the Local Plan Review Steering Group should be based on the political balance of the Council.
- Composition of the group should include the Lead Member covering planning and the Chair of Development Control Committee.

## Terms of Reference

# The group will:

- Make recommendations on the content of the Local Plan to officers prior to consideration of the plan by Council.
- Act as a mechanism for keeping members of political parties informed of progress in reviewing the Local Plan including through circulation of minutes.
- Consider the appropriateness of the evidence base and to provide comments as necessary on particular documents.
- Provide member input to comments made on behalf of the Council to Government, statutory bodies and neighbouring authorities on planning issues.
- Consider any other matters as may be necessary to require the effective and timely review of the Local Plan.
- Expand the number of councillors on the group where a wider range of views are sought, so long as political balance is retained.
