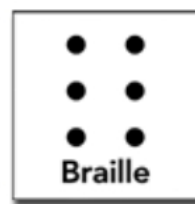
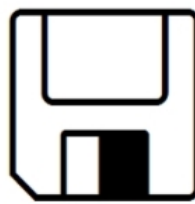
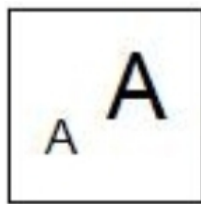

DRAFT ENVIRONMENTAL POLICY STATEMENT

- Developing and participating in partnerships with local, regional and national organisations to improve the management of environmental issues and, in particular, mitigation of and adaptation to the effects of climate change.
- Promoting environmental awareness to all sectors of the community and to those who we can influence including employees, residents, contractors and suppliers and encouraging their involvement.
