**1. APPOINTMENT OF CHAIR**

#### **5. PROPOSAL TO INTRODUCE:**

- **ANNUAL DRIVER LICENCE**
- **ANNUAL STATUTORY DECLARATION**
- **NEW FEE STRUCTURE**

Members of the Council considered the report of the Monitoring Officer relating to the referral from Overview and Scrutiny to reconsider the decision taken by Cabinet on the 14<sup>th</sup> November 2007 to increase the fees for hackney carriage and private hire drivers' licences together with the introduction of an annual fee and annual statutory declaration.

The Chair invited questions from members of the public however no questions were raised.

Various Councillors outlined concerns about the consultation process and discussion was held on the following matters:

- Financial information within the report
- Liaison with the taxi trade thorough the Working Group
- Fees and charges within other areas of the Council
- Licensing Unit Improvement Plan

The following proposal was moved and seconded:

That from the 1<sup>st</sup> April 2008 the following be agreed:

1. That an annual Hackney Carriage and Private Hire Driver Licence be introduced;
2. That an annual Statutory Declaration be introduced;
3. That a fee of £120 for new applications and a fee of £85 for renewal applications be introduced and that they be reviewed annually by the Executive Director of Regulatory Services in conjunction with the Portfolio Holder for a Well Managed Council;
4. That should a Hackney Carriage or Private Hire Driver licence expire, it will be treated as a new application should the applicant subsequently decide to re-apply.

The following amendment was moved and seconded:

That from the 1<sup>st</sup> April 2008 the following be agreed:

1. That an annual Hackney Carriage and Private Hire Driver Licence be introduced;
2. That an annual Statutory Declaration be introduced;
3. That a fee of £120 for new applications and a fee of £85 for renewal applications

be introduced and that it be reviewed annually by the Executive Director of Regulatory Services in conjunction with the Portfolio Holder for a Well Managed Council;

4. That should a Hackney Carriage or Private Hire Driver licence expire, it will be treated as a new application should the applicant subsequently decide to re-apply.
5. That a full review of the costs and services within the Licensing Unit be undertaken:
6. That any further increases be capped at the rate of inflation for the next three years.
7. That Elected Member involvement be re-established through the Taxi Liaison meetings.
