**1. WELCOME AND INTRODUCTIONS**

The Chair welcomed members of the public to the meeting and in agreement with members of the Forum invited Mr Barry Drelincourt of Rossendale Transport to update the meeting on changes to services and fares.

Mr Drelincourt explained which services were free to those residents with concessions and answered questions from members of the public.

#### **4. POLICE UPDATE**

##### **Summary of Update from PC Thomas**

PC Thomas updated the Forum on crime rates and policing in the area and explained that there had been a 1.1% overall decrease in crime for the area. He reported on operations that would tackle drug crime, anti-social behaviour, burglary committed by criminals travelling into the area and joint operations with Greater Manchester Police to combat off road vehicle violations on the moor.

PC Thomas was pleased to further report that a hand held laser speed gun had been purchased for Rossendale and that community operations had been planned for the future.

AGREED - That PC Thomas would update the next meeting of this Forum on night speeding checks between 9.30pm and 10.30pm.

##### **Questions to the Police**

PC Thomas took questions from the public and the following matters were discussed:

- Arson attacks at Mill premises within Whitworth.
- Road safety, recent accidents and speeding concerns.

The Chair thanked PC Thomas for attending the meeting.

#### **5. NEAT UPDATE**

The NEAT Officer provided the Forum with a brief report of issues dealt with between March and June this year including the number of service requests, notices served and prosecutions brought which had resulted in £4,475 of fines.

She further reported that the NEAT teams were currently involved with a number of schools and community groups across the borough to promote and educate residents about the benefits of recycling, neighbourhood grants and generally improve local areas.

The NEAT officer received and answered questions from members of the public on a wide range of issues.

## **6. DETERMINING OF GRANT APPLICATIONS**

There was one application for grant funding which needed further information before being submitted to the next meeting. Feedback had been received from existing recipients of grant funding.
