

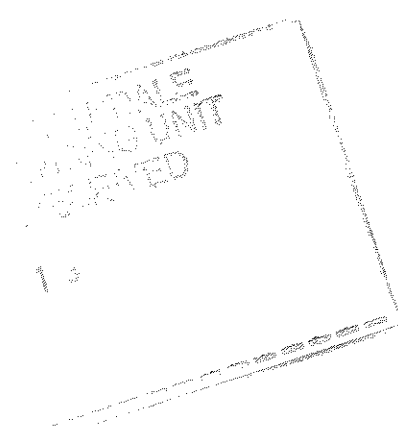

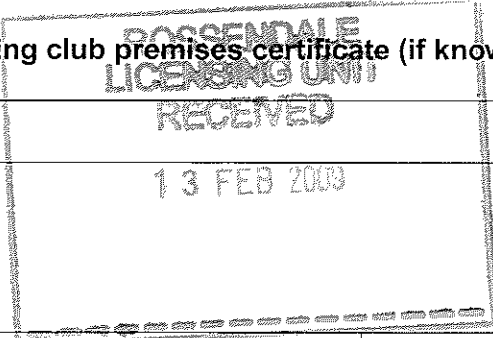

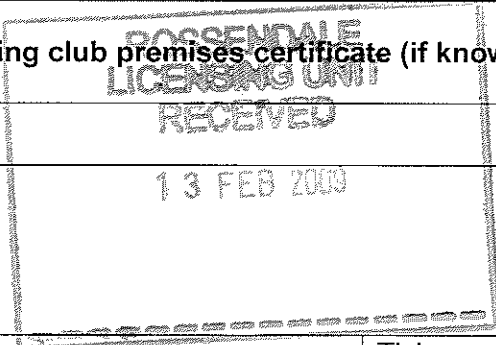

Environmental Health Services object to this application dated 20 January 09 to vary a premises licence in respect of The Roebuck Inn, 1 Charles Lane, Haslingden.

Environmental Health Services consider that the proposed performance of live music and the playing of recorded music until 03.00hrs on a seven days a week basis will be seriously detrimental to the residential amenities of nearby occupiers, by reason of the noise and disturbance and general activity associated with the proposed variation to the premises licence. Whilst the premises is a detached property, both of its gable walls are in close proximity to residential property, and in the case of the Coal Hey Street elevation being just over 12 feet away.

The Roebuck Inn has been the subject of noise complaints during 2006 when an Environmental Health Officer considered that noise levels were excessive and the landlord was required to take remedial action. Currently, there have been no complaints of noise nuisance from amplified music.


