

You will need to obtain a GIRO slip from the licensing unit first. Payments can also be made using a credit or debit card. Please telephone 01706 238 648 to arrange this.

Upon the grant of the street trading consent, a further fee of £275 must be made.

A renewal of a street trading consent costs £350.00.

Street trading is allowed between the hours of 9am to 10pm Monday to Sunday inclusive. The provision of hot food and drink between the hours of 11pm and 5am is a licensable activity under the Licensing Act 2003 and will therefore require a premises licence under that Act.

Street trading consents are issued for a period of 12 months.
