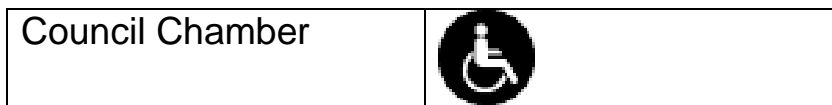

## Transport Arrangements

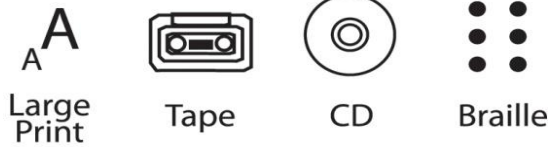
