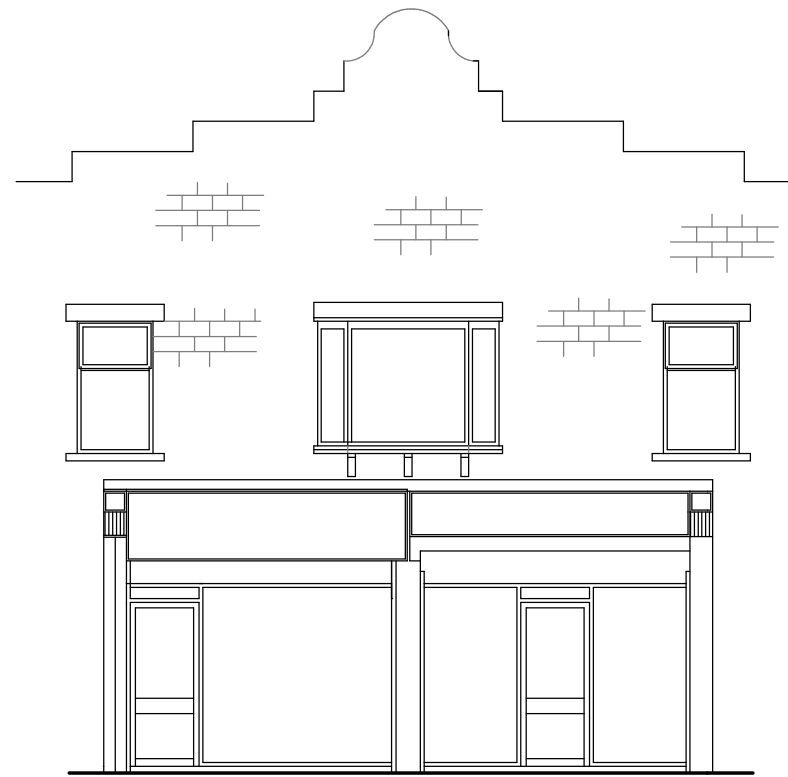

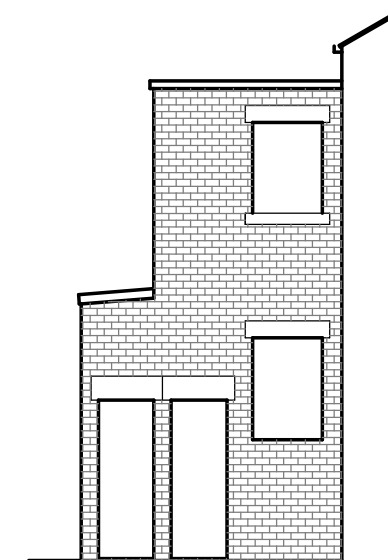

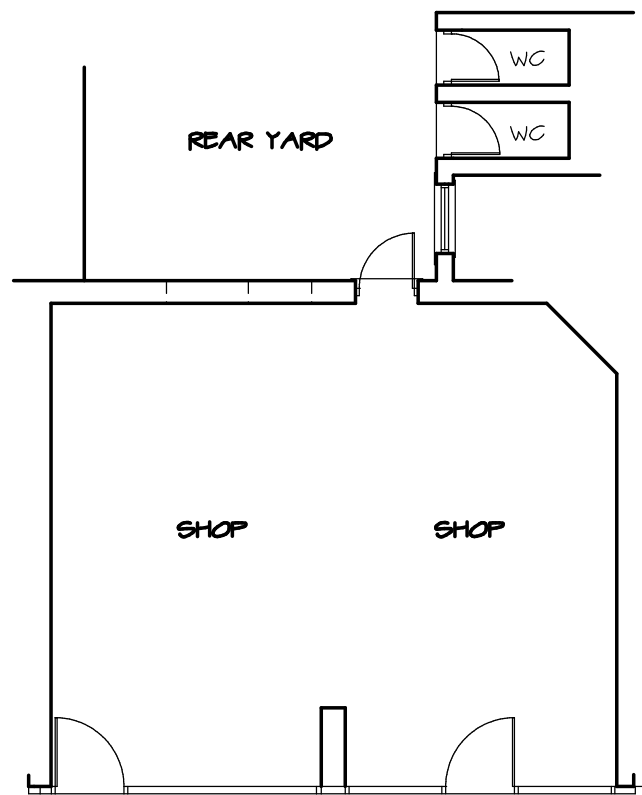
BANK STREET ELEVATION

REAR SIDE ELEVATION



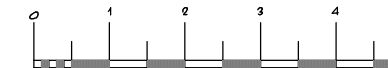
GROUND FLOOR PLAN VIEW

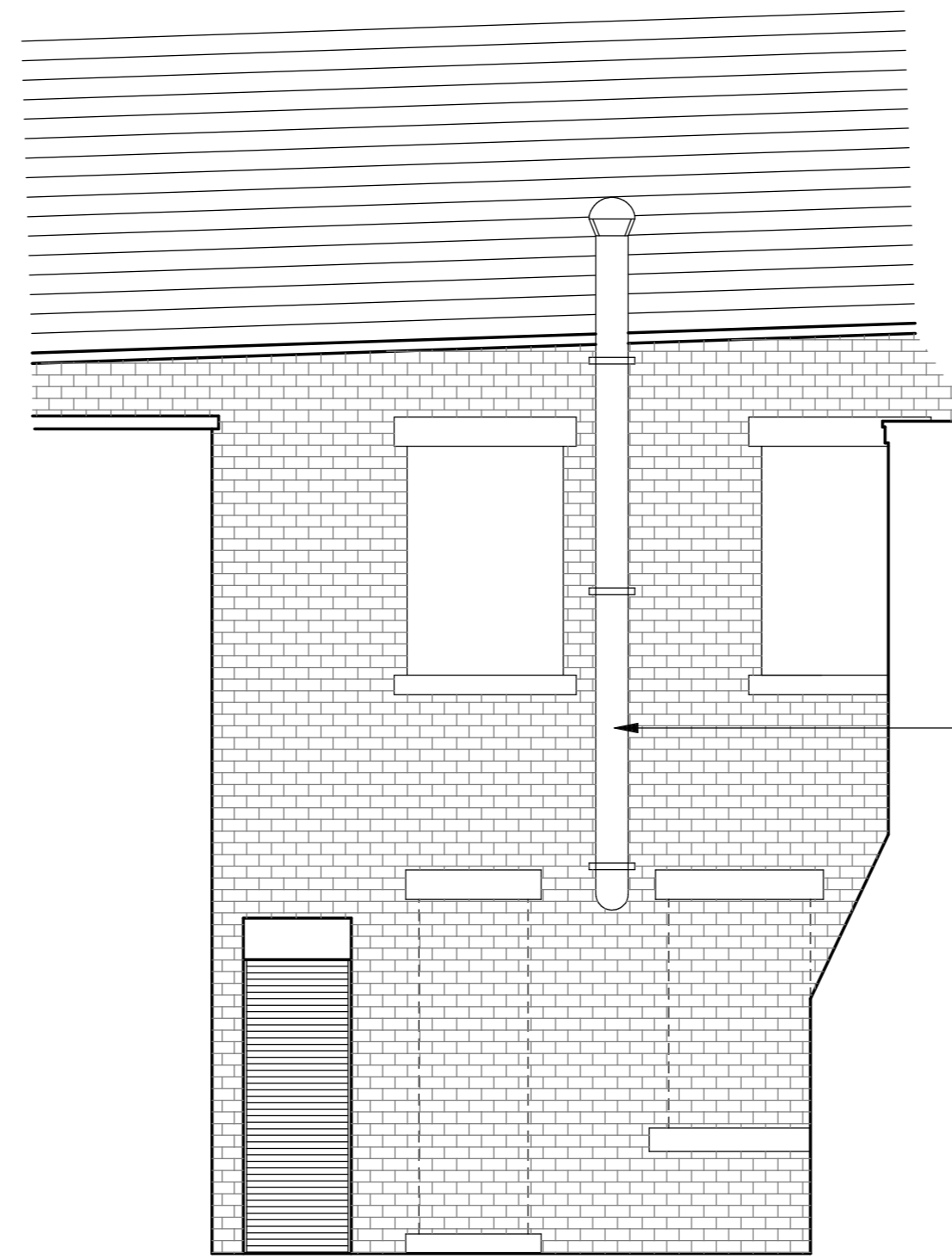

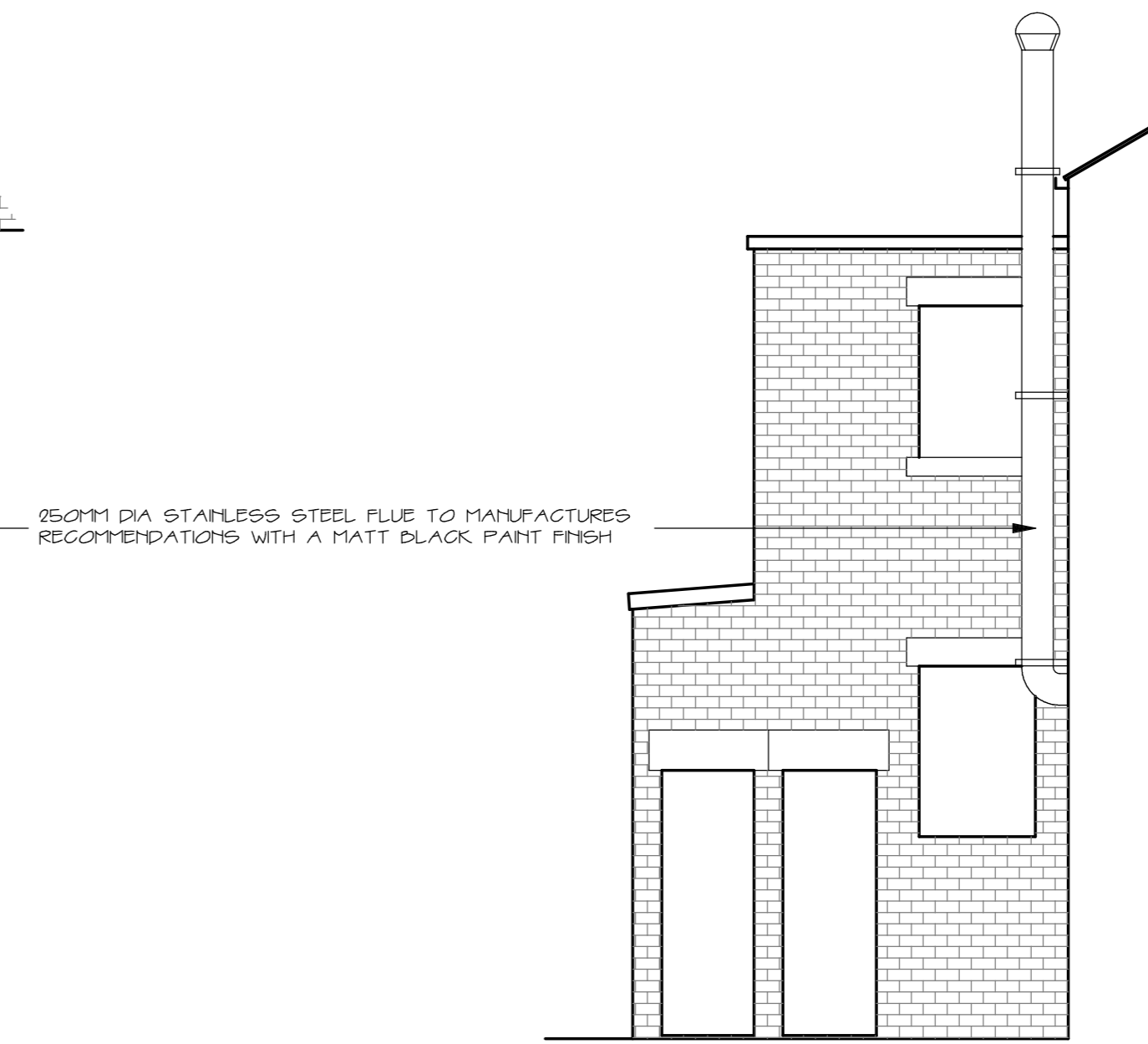

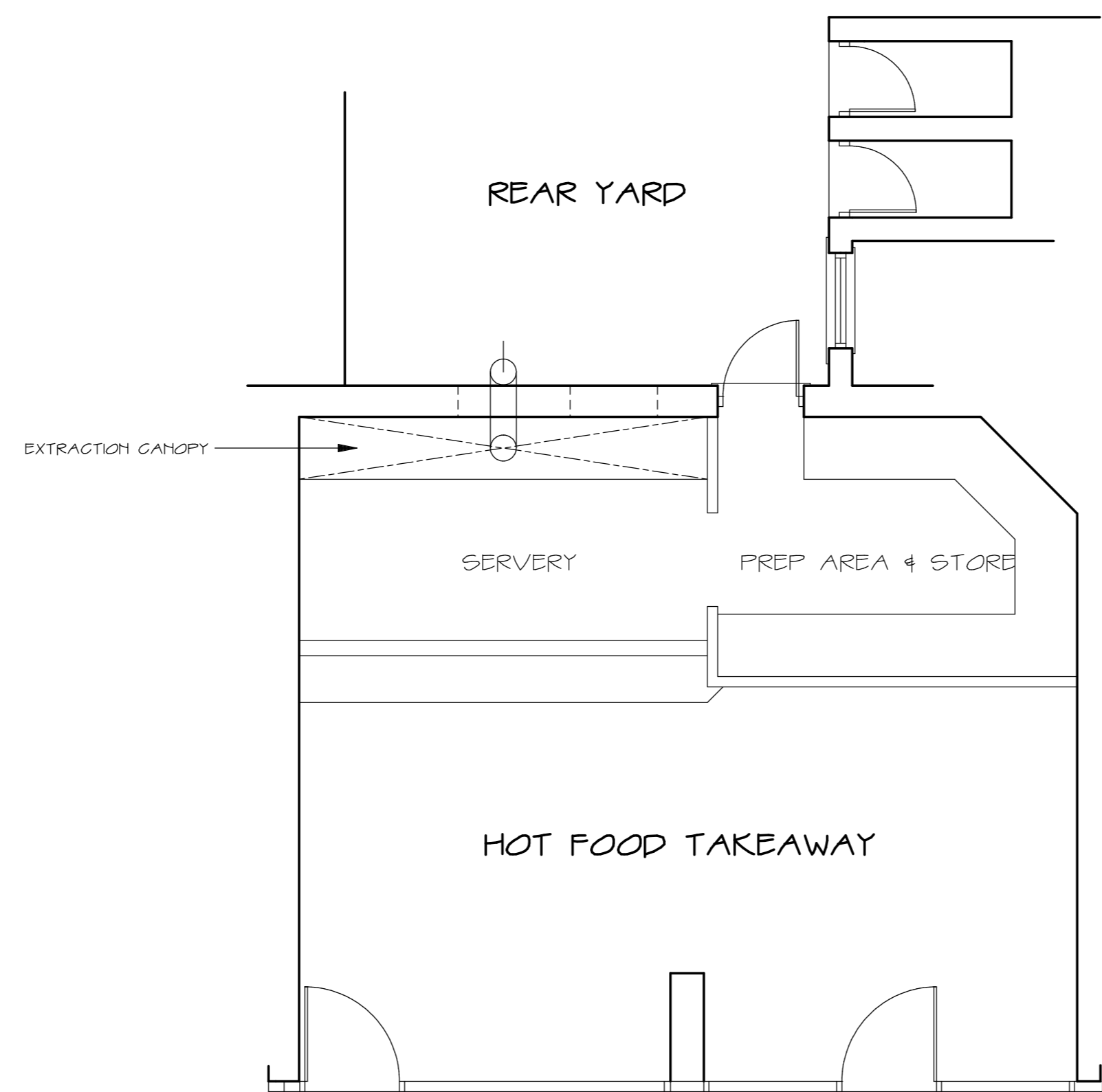
BANK STREET ELEVATION



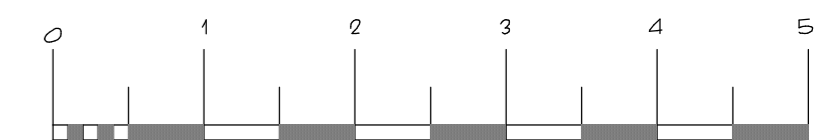
REAR ELEVATION
