### **Transport Arrangements**

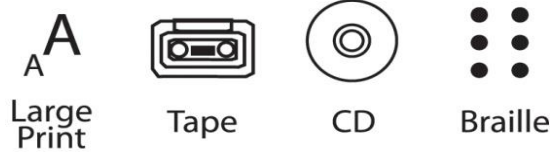
