

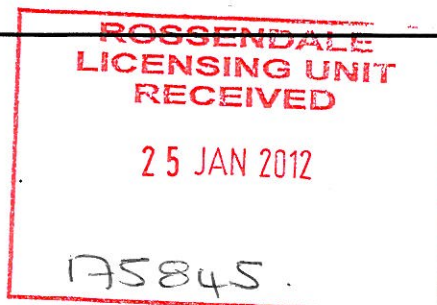

We are seeking to extend our hours from 1am on Friday, Saturday and Sunday, to 2am. We also request a longer drinking up time of 3am. After consulting with the Police, we feel this would be safer, and would assist with the reducing of noise and Public Order offences.

We also wish to vary the existing condition about door supervisors to include 2 door supervisors only, rather than 2 on duty for the first 100 customers and thereafter, one for every 100, or part, thereof.

We would also like to remove the maximum number of persons permitted in the premises, due to the addition of a new fire door. (Number to be agreed with Fire Officer).

We have also made 4 physical alterations to the internal part of the premises, these have been marked on the plans.

- ① Part of the wall has been removed into what was the old pool room.
- ② The Bar has been moved to a new position.
- ③ A new entrance has been constructed on Beadogate.
- ④ The male toilets have been re-located next to the existing ladies toilets.

**a) General – all four licensing objectives (b,c,d,e) (please read guidance note 9)**

The Premises Supervisor and Bar Manager will seek an active role in Pubwatch, and will vigorously pursue the aims of pubwatch.  
We will be employing a policy of challenging anyone who appears to be under 23 years of age.

**b) The prevention of crime and disorder**

We will be employing door supervisors during permitted hours.  
We have removed our pool table and opened up an internal wall to be able to police the premises more effectively.

**c) Public safety**

The Premises will be supervised by the DPS and all other staff employed.

**d) The prevention of public nuisance**

Signage on the premises suggesting all customers leave in a quiet orderly fashion.  
The DPS and employed staff will ensure the noise emitting from the premises is kept to a minimum.  
An application is to be made to provide double glazing to also reduce noise.

**e) The protection of children from harm**

Children will only be allowed on the premises until 19:00 hrs, and will not be permitted in the Bar Area.
