Hi Tracy

Following on from this morning's discussion, our last bus from Bacup is 23:08 towards Rawtenstall on Mondays to Saturdays (and earlier on Sundays).

The first departure from Bacup is 05:35 on Mondays to Fridays (this bus actually turns at Bacup), so the taxis would need to be off the bus stops before this time.

Therefore, we'd have no objection if the bus stops in St James Square were to become a taxi rank from 23:30 until 05:00.

Stone throwing at vehicles in this particular part of Bacup is nothing new – I can remember back to my days in the early 1990s, as a bus driver in Rochdale, we used to have problems on the late evening journeys between Rochdale and Bacup, which in those days went round Pennine Road and then terminated at the bottom of South Street. We quite often had windows broken whilst we waited for time.
