Dear

I would like to express my objection to the proposal to put a taxi rank for 5 taxis on King Street Bacup. I work at the Citizens Advice Bureau on King Street and there are already serious problems for us and neighbouring businesses due to insufficient parking in the area. The removal of 5 parking spaces will inevitably make this situation worse.

We have a large number of clients, volunteers and members of staff who have mobility problems. It is vital for them that they are able to park near to the Bureau. I believe that it has been suggested that we use the parking at the police station and opposite the post office. This would not be accessible to those people due to the distance from the Bureau and the elevated position of both areas. Also these areas are generally felt to be unsafe due to it being poorly lit.

The taxi drivers have stated that they have been subject to vandalism on their cars on their present rank. Should this matter not be resolved by the police rather than moving them?

I would therefore ask that the Licencing Committee reject the proposal.

I wish to object to the proposal to appoint a Hackney Carriage Stand at King Street.

King Street is currently used for parking by both workers and shoppers as it is accessible to the businesses in the locality. It is well used and busier now that other on-street parking around Gas Street and Henrietta Street and the car park at Henrietta Street have disappeared for the siting of Morrison's.

The positioning of a Hackney Carriage Stand on King Street would reduce the limited parking facilities still further.

The businesses along King Street (and Union Street) rely on clients, customers and workers, particularly those with mobility problems, to be able to park and have access to the properties easily.

Alternative long-stay car parks at Bank Street and Fern Street are not suitable for alternative public parking as they are remote and, in winter, dark, especially for workers or shoppers who may well be alone and having to return to their vehicles in an evening. They are also not suitable for anyone with mobility problems. Regularly in snowy or icy conditions these car parks are inaccessible.

I therefore feel that King Street is not the place for a Hackney Carriage Stand as it would have a negative impact on many people by reducing level, accessible, central parking facilities.

I am writing on behalf of the staff of Irwell Medical Practice to object to the Council's proposal of putting a taxi rank on King Street in Bacup.

Parking for workers in Bacup is bad enough as it is, and the introduction of the new Morrisons will only make it worse. If King Street is made into a taxi rank it will be near impossible for workers to park. There are no practical car parks available for staff at the Health Centre or in Bacup itself.

Myself and one of your colleagues spent many hours traversing the hills and side streets of Bacup trying to locate a safe and secure alternative for staff parking and came up with nothing.

I volunteer at the Citizens Advice Bureau and would like to raise objections to the proposed siting of the taxi rank on King Street in Bacup. I have mobility problems and am registered disabled. Although we have some parking at the rear of the building we still struggle to find parking spots. Many of our volunteers are elderly people who have retired and have mobility problems. With parking posing such a big problem, we will really suffer and I will simply not come. Plus we deal with a wide range of people with failing health conditions and these people cannot walk or use public service, again we will suffer for parking spaces for these people. We would ask you to look at other venues for the siting of this rank, i.e. where the Old Health Centre used to be or even the site you originally gave them behind "Lynns Cafe". We recall that a site was put on King Street some years back and the taxi drivers refused to use it then and it was left empty.

19% of Rossendale CAB customers are disabled.

There is little level-access car parking in Bacup. The Council has already removed the level access car park at Henrietta Street to provide additional space for Morrisons. Its latest proposal is a "double whammy".

In our view the Council should include such provision as part of the Morrisons development.
