1.	RECOMMENDATION(S)
1.1	That Full Council notes the update to the grounds maintenance schedules as detailed within the report and approves the changes to the grounds maintenance schedule as detailed in the report and appendix 3.
1.2	That Full Council approves that all future minor amendments to the Parks and Open Spaces grounds maintenance schedules are delegated to the Head of Operations in consultation with the Portfolio Holder.

2. PURPOSE OF REPORT

- 2.1 The purpose of this report is to update members on feedback received during 2014 after the changes to the Parks and Open Spaces service and to make recommendations for the future approach to our grounds maintenance schedule.

3. CORPORATE PRIORITIES

- 3.1 The matters discussed in this report impact directly on the following corporate priorities:
- **Responsive Value for Money Services:** This priority is about the Council working collaboratively, being a provider, procurer and a commissioner of services that are efficient and that meet the needs of local people.
 - **Clean Green Rossendale:** This priority focuses on clean streets and town centres and well managed open spaces, whilst recognising that the Council has to work with communities and as a partner to deliver this ambition.

4. RISK ASSESSMENT IMPLICATIONS

- 4.1 Not reviewing feedback received as a result of changes may result in loss of confidence from staff and residents in the council as a supportive and understanding council.

5. BACKGROUND AND OPTIONS

- 5.1 In winter 2013/14 a number of changes to the grass cutting and grounds maintenance schedules were agreed at cabinet with a formal request that feedback resulting from those changes and any suggested alterations to that plan were brought to Scrutiny Committee for review and approval.
- 5.2 The changes were implemented and throughout the grass cutting season feedback has been recorded and reviewed from the following sources: residents service requests and enquiries; formal complaints; member enquiries; MP enquiries and grounds maintenance teams. A summary of this feedback and suggested alterations are covered in the following sections.

5.3 **Feedback from residents, member enquiries and MP enquiries.**

We have 115 recorded service requests/ enquiries and 1 formal complaint (which was of a general matter and not related to any specific site). Some sites only received one query throughout the year, whereas other sites had multiple queries relating to them. All sites have been reviewed regardless of the number of enquiries; however those with multiple enquiries have been focussed upon. Some of those sites with multiple enquiries received an alternative trial regime during the season to assess the response and allow a more accurate suggestion for next years schedule. A list of those sites, the number of queries relating to each and action taken or suggested is included as Appendix 1.

5.4 From interpretation of the feedback the main points of concern or query from residents were:

- A lack of understanding about the concept of perimeter strips being mown, especially when the unmown area starts to look unkempt.
- The areas of grass in front of their houses are really important to them. Originally these areas were considered a low priority from previous consultation; however people want to look out on to well-maintained areas.
- With increased car parking the verges on housing estates need to be crossed by residents and they want to be able to easily walk across short grass.
- Leaving areas of long grass has caused concerns over dog fouling and litter, although there is little evidence from service requests to suggest there has been an appreciable increase in either.
- There are some areas of grass within housing estates which are not formal play areas but are the areas of open spaces where children like to play. These should be accessible and useable so that children are not forced to play in the road.
- Perceived inequalities between areas.

5.5 **Feedback from grounds maintenance teams.**

Both formal and informal feedback sessions were carried out with teams throughout the grass cutting season to assess the impact upon them and the machinery. The main points of considerations are shown in Appendix 2. Towards the end of the grass cutting season the parks and open spaces manager, team leader and grounds maintenance team charge hand visited every site on that teams route and agreed an appropriate regime for that site taking in to account the feedback from external sources, site conditions, site location and overall workload.

5.6 **Feedback from user groups.**

We have received feedback from some bowling clubs. Those which opted for a once per week regimes have found that playing conditions were not always suitable. The bowling green mowers in use this year had limited capabilities due to their age; however they are due for replacement during winter 2014/15 which will improve the quality of cut.

5.7 **General observations**

The mild winter preceding the typical grass cutting season meant that grass growth was of an exceptional rate during spring. In previous years the preference was for increased seasonal resource commencing from May onwards to enable the mowing regime to continue for longer during autumn. However with hindsight it would have been better to have increased resource in place earlier. Consequently we aim to increase the resource no later than the first week of April in 2015 to ensure that we have sufficient staff resources in place when grass growth is at its fastest. This should prevent some of the issues met this year such as long intervals between visits and lines //piles of grass clippings left on the surface. Although it must be recognised that we no longer collect grass clippings and there will always be a deposit of grass on mown surfaces.

5.8 A number of sites which were not mown throughout the majority of the season presented issues due to unwanted vegetation types growing - particularly dock. These sites looked rather untidy compared to those which consisted only of grass and short herbaceous plants. A regime to control the dock consisting of either timelier mowing in midseason to prevent dock from growing tall or flowering, or in some cases an application of selective herbicide to kill off the dock and retain the grass is factored in to new schedules.

5.9 The schedule of works carried out by the tractor team has been prioritised to ensure facilities used by sports clubs are maintained to a satisfactory condition.

5.10 **Clarification of regime.**

Taking in to account feedback from all sources and in particular the request from teams to create a simpler system the following categories for mowing regimes will be adopted.

- **Weekly**

Sites will receive grass cutting once per week.

- **Regular (whole or part site)**

Sites will receive a cut each time the team carry out one cycle of the mowing route.

There may be some exceptions due to growth rate and / or site conditions at the time – the teams will monitor this and select the appropriate course of action.

The extent of the mowing area is written on the schedule. Where only part of the site is due to be mown the extent of this area will be at the discretion of the team depending on visual characteristics and ground conditions at the time.

The frequency and interval between cuts can be variable depending on site conditions, rate of grass growth and resources available.

- **Low frequency (whole or part site)**

Sites will receive grass cutting 1-3 times per season. The timing and number of cuts will be at the discretion of the team and depends on a number of factors – site conditions, rate of grass growth, vegetation type on site and resources available.

The extent of the mowing area is written on the schedule. Where only part of the site is due to be mown the extent of this area will be at the discretion of the team depending on visual characteristics and ground conditions at the time.

- **Litter Pick Only**

These sites will receive no grass cutting and have been selected upon location, vegetation type and grass growth. Teams will only attend to any issues upon receipt of a service request.

Other regimes may be specific to a particular site type, such as sports pitch, or more complicated due to the size and nature of the site. These are detailed along with the full site list in Appendix 3.

It must also be recognised that at any time resources present challenges then sites such as parks, gardens, play areas and cemeteries will take priority over amenity and public realm sites.

9. CONCLUSION

The next grass cutting season may still present issues and therefore further alterations cannot be discounted. The extent and nature of these will determine if those alterations can be made throughout the season or require a more extensive review.

Appendix 1: Grass cutting – number of site specific service requests relevant to changes and action taken or suggested.

Sites with 7 separate queries	Action
Meadows Drive	Important for children's play. Site was added back on to the schedule as a trial from July. This resulted in positive feedback and so it will become a regularly visited site. The lower end of the site can often be wet and therefore this may not be own on very occasion.
Wallbank Estate / East gate	Important for children's play and access from verges. Site was added back on to the schedule as a trial from July. The team feel this is a more appropriate regime. No further complaints or queries since adding back on. It will be a regularly visited site.
Sites with 6 separate queries	
Edgeside Park	Main Park. Residents concerned about the amount of unmown grass and that it makes the park look neglected. There are general concerns about this park being considered less important than others. Consequently the team will be carrying out work throughout winter to make noticeable improvements. Resources do not allow us to start mowing the whole park again however the extent and pattern of mowing will be altered to find a satisfactory compromise.
Sites with 5 separate queries	
Reedsholme	Important for children's play. Site visit with ward councillor occurred in July. Site was added back on to the schedule as a trial from July. This resulted in positive feedback. The large flat field area will become a regularly visited site and the banking and area under trees will receive a low frequency regime.
Sites with 4 separate queries	
Carr Mount	Small area right outside housing. Area was receiving perimeter cut, however central area contains dock adding to poor appearance. Site will be added on to schedule as a low frequency (trees hinder grass growth) to prevent dock from becoming noticeable or dominant.
Knowsley Crescent	Banking between housing. Site visit with ward councillor in July. A site which has historically generated service requests. Main part of site was added back on during July. This resulted in positive feedback and so it will become a regularly visited site with the exception of the steepest section of the banking (which cannot be safely accessed by mowers or strimmers) which will receive a low frequency flail cut.
Sites with 3 separate queries	
Heathfield Road	Verges on housing estate. The main verge of concern was receiving a perimeter only cut, however dock encroachment is apparent. Residents do not see the point in the perimeter cut. The site will be added back on as a low frequency cut as it is located on the far side of the road from housing. Other verges in that locality which are in direct proximity to housing will receive regular cuts.
Heys Street	Ex play area. Site meeting with ward councillors and local MP to discuss site requirements took place in summer. The honeycomb matting has been removed and a grass surface will be reinstated to create a small informal area suitable for kick abouts and general recreation. This area will receive a regular cut with surrounding areas scheduled for a low frequency regime. Crown raising trees and reducing the height of the hedge on the lower section of this site is on the tree team winter programme.

Hollin Way	Verges on school route. Concerns about appearance of the perimeter only cut at the junction of Hollin Way and Burnley road. The perimeter cut will continue on a regular basis; however a low frequency cut of the remaining areas is scheduled to improve overall appearance.
Priory Close	Verge at entrance to close. Residents are concerned about appearance of long grass. Dock encroachment is apparent. The grass is not directly overlooked by housing and will be assigned a low frequency cut to control the dock and provide a smoother appearance.

Appendix 2: Summary of feedback from grounds maintenance teams during 2014

- Doing perimeter strips or small parts of sites means that travelling, loading and unloading takes up a disproportionately high amount of time compared to actual grass cutting. It would be better to either do the whole site whether that be on a regular basis or less frequent basis depending on location and site conditions.
- Spring started quite early and grass growth was exceptional at the start of the season. We need to plan for a similar event and start temporary seasonal staff earlier to ensure there are enough resources to cope.
- Grass growth been so lush when sites have been visited it has needed up to 3 passes with mower to cut it to any quality – therefore increasing time per site and overall increasing time between each cut, thus exacerbating the initial problem of frequency at start of season.
- Increased wear and tear on machinery has been very apparent. Belts, blades, motors – wearing within 2-3 weeks at the start of the season.
- The combination of weekly sites, fortnightly cemetery work, twice weekly or once weekly bowling greens, then high priority and low priority grading makes the whole system of determining which areas to cut in which order over complicated. Would prefer to get back to a simpler system.
- So much focus on grass complaints and trying to get this in order that other work may have suffered – e.g. beds and borders. Consider separate team for this type of work and other elements such as JK spraying, bedding that will take pressure off amenity teams.
- Work including Japanese Knotweed spraying, closed churchyards, public realm work and bedding come at time of year when the grass is growing very fast. The reduction of staff and increase annual leave has shown that staff being taken off normal route to complete these tasks is having a greater effect as it affects a greater % of overall workforce compared to previous years.
- Car parking on highways is becoming a major problem and is often preventing teams from being able to park and unload near to the site and / or being able to physically cut the verge due to risk of hitting vehicles with equipment or stones being thrown out. This results in additional time taken to mow the site or having to return to sites on another day to try and gain access – this all adds time on.
- Teams know the site conditions, rates of grass growth and often the type of users. They would like the flexibility to decide the extent and frequency of grass cutting within parameters so that they can adapt to changing conditions and resource levels.
- The flower meadows look good in the right location and can reduce the grass cutting burden at peak times. However to create the meadows and then maintain them during establishment takes up some time so the number and extent needs to be carefully planned so that they can cope.
- The bowling greens which are only being cut once per week are taking much longer to cut when we do visit. There is no appreciable time saving and it would be better to revert to a twice weekly cut as previously done.
- The reduced reliance on bedding displays has helped

Larger parks will continue to receive a variable mowing regime with some areas receiving higher levels of attention than others to reflect formality and use of specific areas within the park.

Cemeteries

Cemeteries remain high priority sites due to the formality and nature of the site. Mobile teams will visit the cemetery one day per fortnight to assist charge hands. Chargehands will carry out grounds maintenance duties at other times. The amount and frequency of mowing at any given time is very much dependent on the number of burials and staff resource, however staff feedback has indicated that this regime is appropriate.

Perpetuity plantings will cease as we have not been able to satisfactorily maintain over recent years. A clause in agreement allows the council to do this. Staff support this proposal as it will allow them to focus on the remaining aspects of maintenance and make improvement elsewhere. Those graves with perpetuity plantings will be converted back to grass throughout winter allowing ease of mowing in summer. Any reusable plants will be relocated within the cemeteries.

Maintenance will focus on burial plots with perimeters and wooded areas being left naturalised.

Amenity sites / public realm

The nature of these sites is variable and this is reflected in the range of suggested regimes. The feedback received from all sources has been taken in to account when planning this schedule. It has been the regime adopted for these sites which has led to views of perceived inequalities between areas. Each team has a route of equal proportion. Each site is assessed individually and while location is a factor, it is not the general location in terms of ward or town, but its precise position in relation to features such as a school, housing, road junction, gateway to the borough and others. By taking in to account residents feedback the main areas of concern will have been addressed.
