- 5.2 The majority of risks have been ranked as low in status for Quarter 3, this means that they have been seen by responsible managers as lower in likelihood and impact. This ranking is based on the mitigating actions in place to manage this risk. The red risk in Quarter 3 is F&PS02 and is in relation to the Council budgets.

- 5.3 Amber Risks are higher than previous quarters.
- 5.4 Risk Management Training has been rolled out to staff and Members over quarter 3.
