

**MINUTES OF: LICENSING SUB-COMMITTEE

1. APOLOGIES FOR ABSENCE AND NOTIFICATION OF SUBSTITUTES

There were no apologies for absence; all councillors were present.

2. DECLARATIONS OF INTEREST

No declarations were made.

**3. DETERMINATION HEARING: APPLICATION FOR PREMISES LICENCE – 96
MARKET STREET, BACUP, LANCASHIRE, OL13 0AY**

3.1 Members considered an application for a premises licence to be granted for 96 Market Street, Bacup, Lancashire, OL13 0AY.

3.2 The application had previously been deferred, but following an agreement between the applicant and Environmental Health with regard to reduced hours for entertainment and the addition of conditions, the application was now before members for consideration.

4. HEARING PROCESS

4.1 The Licensing Officer presented the report which detailed an application for a premises licence, submitted by Mr I Ali.

4.2 An objection had been received from the Environmental Health Team.

4.3 The Licensing Officer made the panel aware of the agreement reached between the applicant and Environmental Health as detailed in Appendix D.

5. DETERMINATION

5.1 In determining the application, the panel gave consideration to the following:

- Hours had been changed from the original application.
- Extra conditions could be added to the licence.

6. DECISION

6.1 After giving consideration to the amended application; and after giving proper consideration to the Licensing Objectives, the Sub-Committee appointed under the Licensing Act 2003 decided to take the following action on the application under Section 18 of the 2003 Act.

Resolved:

That the application for the premises licence be granted subject to mandatory conditions and those detailed in the report having been offered by the applicant and conditions imposed by this hearing which are as follows:

1. There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public, notices in font size 16 or larger requiring customers to leave the premises and the area quietly.
2. At all times that live music is being provided at the premises, all doors and windows shall be kept closed, save for access and egress.
3. When licensable activity is taking place from the premises, the side door which leads onto Rockcliffe Road will be used as an emergency exit only.
4. Live and Recorded Music:
Between 1200 hours and 2300 hours Monday to Thursday.
Between 1200 hours and 0000 hours Friday to Sunday.
5. Supply of alcohol: as applied for.
6. Late night refreshment: as applied for.

The additional conditions are considered necessary are necessary to promote the following licensing objectives:-

- Prevention of Crime & Disorder
- Protection of Public Safety
- Prevention of Public Nuisance
- Protection of Children from Harm

A determination notice would be served on all parties in due course.

There was a right of appeal for all parties before the Magistrates' Court which must be exercised within 21 days of service of the Decision Notice.
