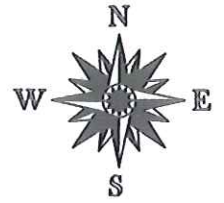

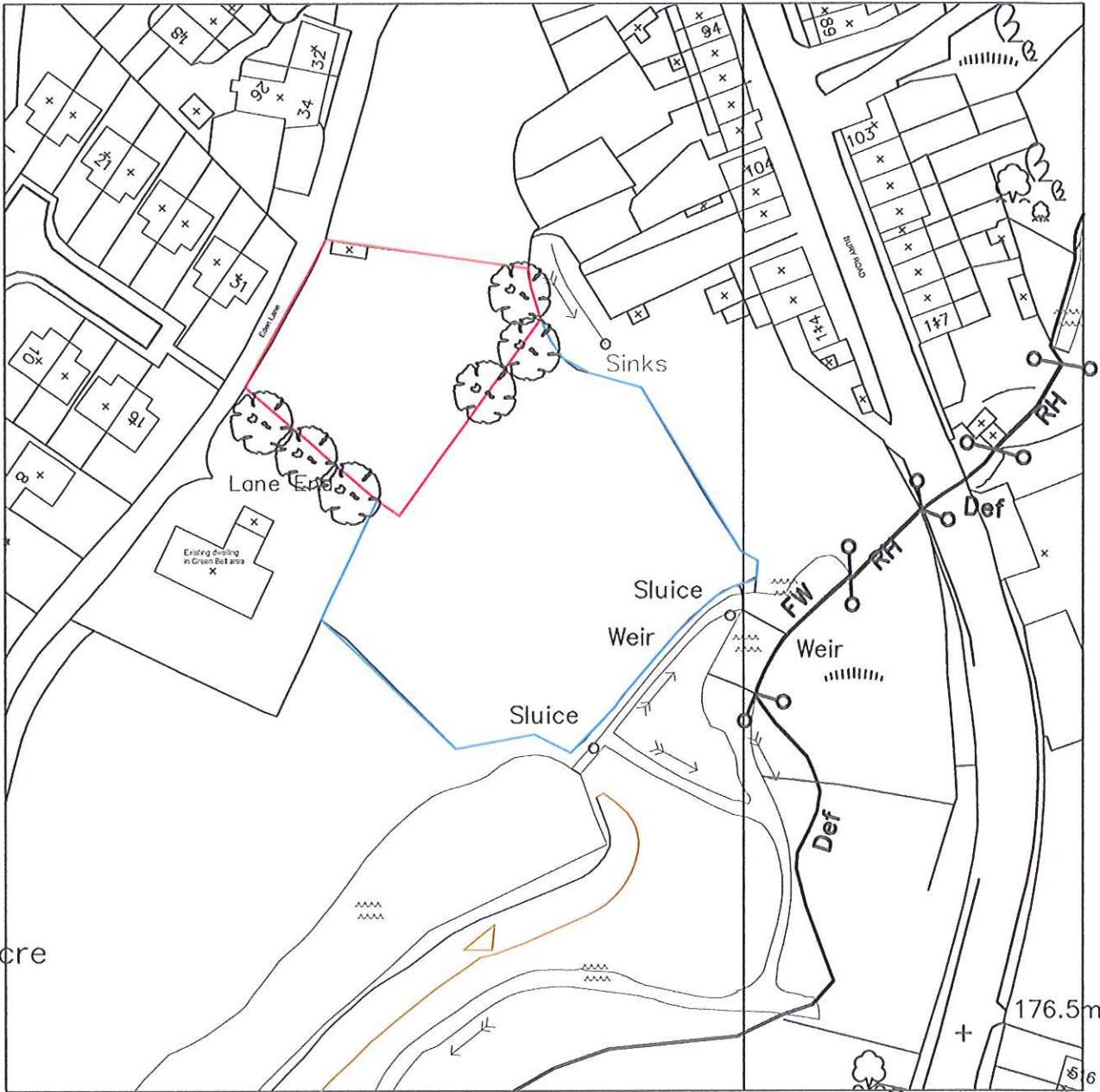

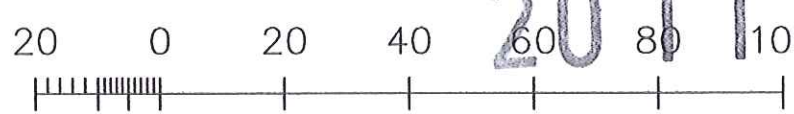


Ordnance Survey Plan



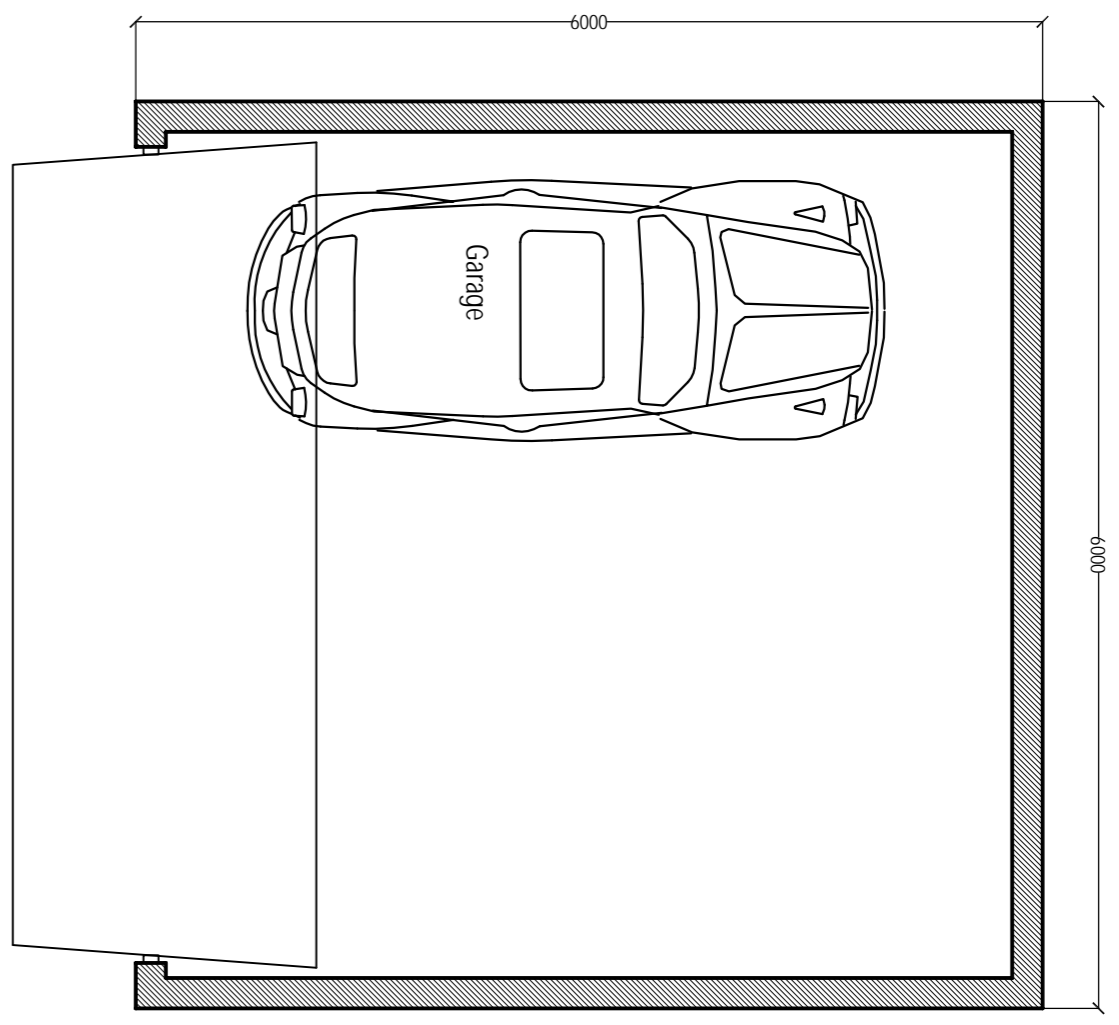

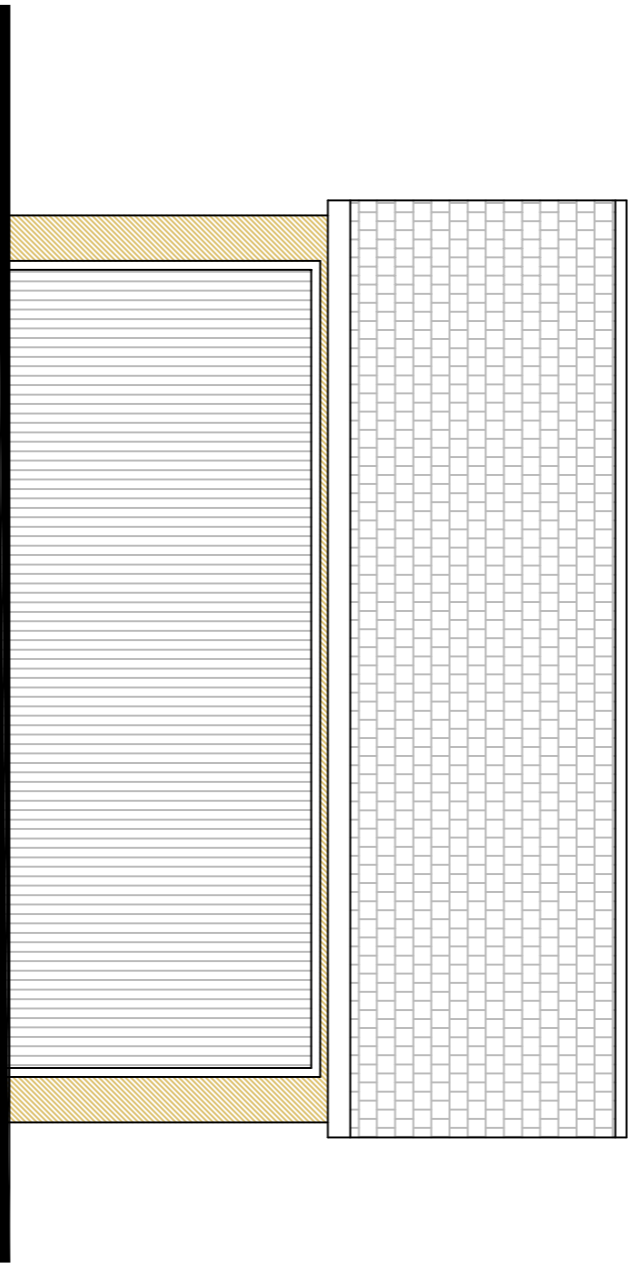




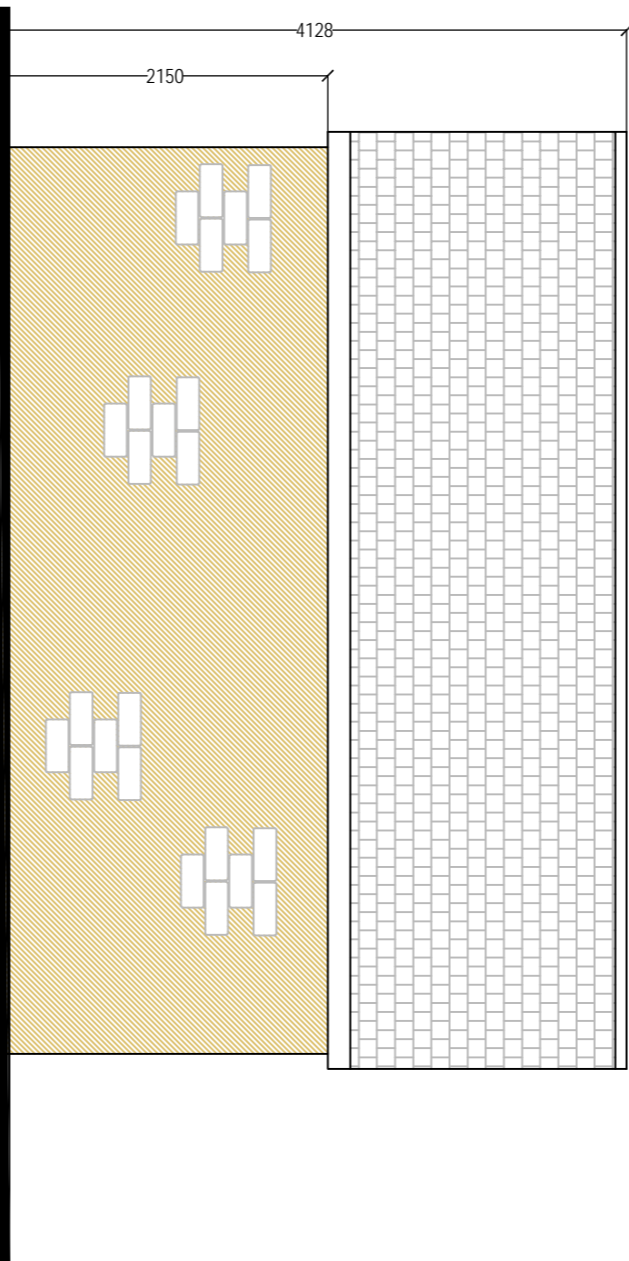
Plan Layout



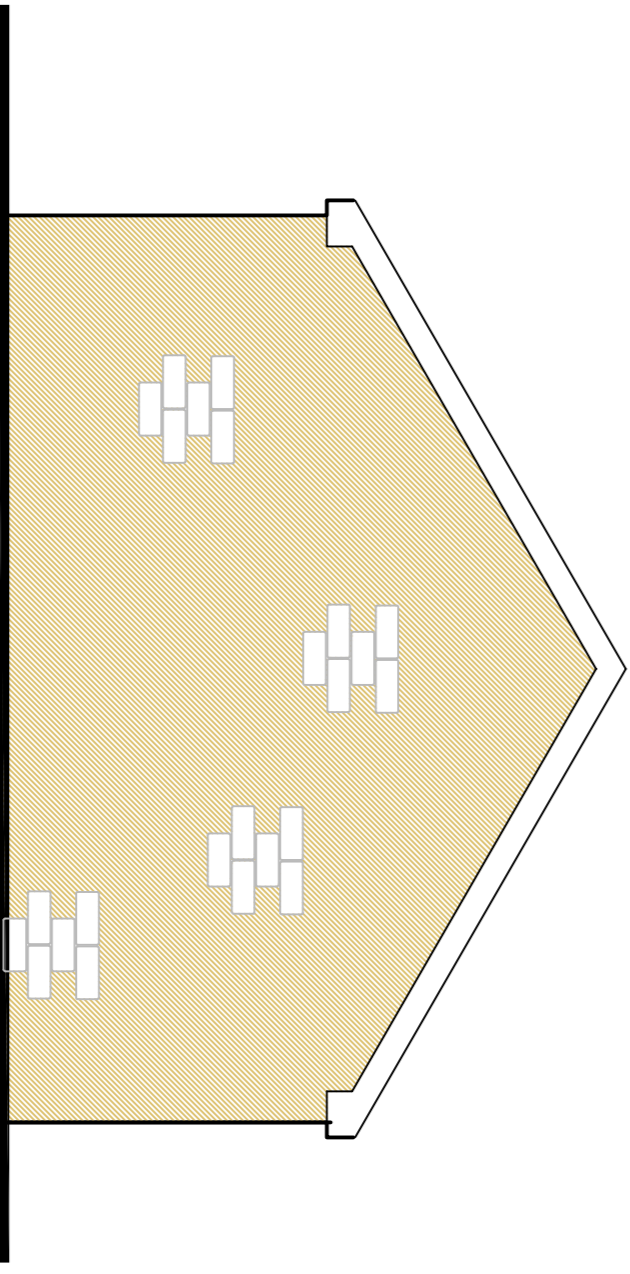
Roof Plan



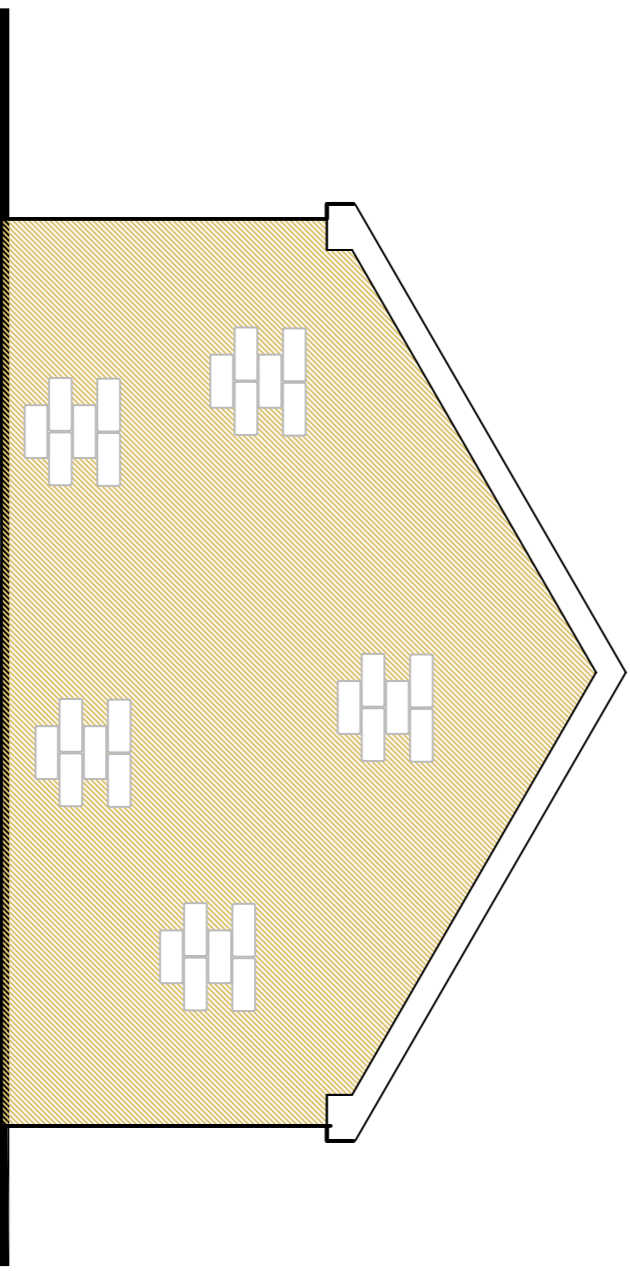
Front Elevation
