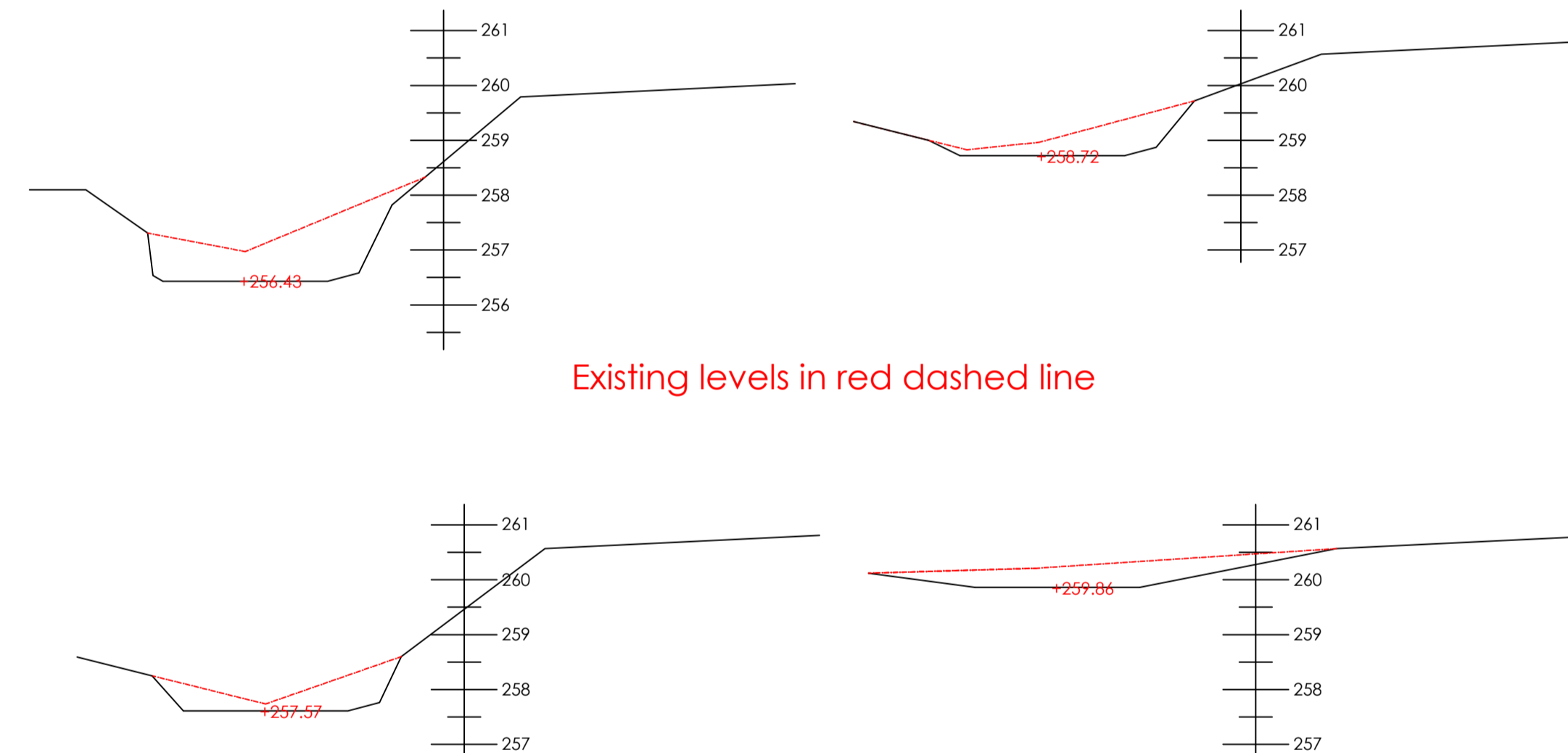
Site Plan
