

# EDENFIELD COMMUNITY NEIGHBOURHOOD FORUM RE-DESIGNATION CONSULTATION

Rossendale Borough Council received an application from Edenfield Community Neighbourhood Forum on 5<sup>th</sup> January 2023 to be re-designated as the Neighbourhood Forum for Edenfield Neighbourhood Area. This application was made ahead of the expiry date of the original designation on 22<sup>nd</sup> April 2023.

The Council hold a six-week consultation to obtain the views of statutory consultees and interested parties on the re-designation of the Forum between Wednesday 18<sup>th</sup> January and Wednesday 1<sup>st</sup> March 2023. In order to publicise this consultation, the Council published information on its neighbourhood planning section of the website, emailed approximately 270 contacts including residents living in Edenfield, Edenfield Community Neighbourhood Forum and Edenfield Village Resident Association. The consultation was also advertised on social media via Facebook and Twitter.

20 responses were received with no objections to the re-designation of Edenfield Community Neighbourhood Forum for Edenfield Neighbourhood Area. 5 responses came from statutory consultees (National Highways, Lead Local Flood Authority, Historic England, The Coal Authority and Homes England) who had no specific comments to make on the re-designation. One response was received from a local Councillor and fourteen representations were made from residents who were all in support of the re-designation of the Forum.

A list of the responses received including their reference number is shown in the next page. The redacted responses are provided next, starting with the ones submitted online via the Smart Survey form, followed by the representations received by emails.

Thank you for your notification received on the 18<sup>th</sup> January 2023 in respect of the above consultation.

The Coal Authority is a non-departmental public body sponsored by the Department for Energy Security and Net Zero. As a statutory consultee, The Coal Authority has a duty to respond to planning applications and development plans in order to protect the public and the environment in mining areas.

Our records indicate that within the Edenfield area there are recorded coal mining features present at surface and shallow depth, in this case coal outcrops which may have been subject to historic workings. If shallow coal workings are present then these may pose a potential risk to surface stability and public safety.

It is noted however that this current consultation relates to an application for re-designation as a Neighbourhood forum for the Neighbourhood area. I can confirm that the Planning team at the Coal Authority have no specific comments to make on this current consultation.
